## FEMALE UNDER-REPRESENTATION IN GOVERNMENT

AND ITS SOCIO-ECONOMIC IMPACT

- At present, Sri Lanka is ranked 182 out of 193 countries on the interparliamentary union of rankings
- In the previous parliament 13 legislators, or rather a handful of 5.8% of 225 MPs represented the voice and needs of 52% of the population
- There was only one woman under the age of 40 in parliament that represented the needs of young women
- Newly elected parliament one Cabinet and two female State
  Ministers with five more female members of parliament being elected
  by popular vote. Moreover, SLPP, SJB, and NPP have collectively
  appointed four female representatives through their National Lists

- The World Gender Gap Report published by the World Economic Forum ranked Sri Lanka amongst the top 20 countries in 2006.
- However, Sri Lanka has slipped in the rankings to be 102 out of 153 countries

### Female migrant workers and remittances

- Total migration for employment 2018 38.6% (population and labour force, CBSL 2019)
- Remittances to Sri Lanka totalled to USD 7.015 billion
- In 2018, remittances accounted for 7.8 % of the GDP, and could cover 59% of the total import bill or over 13% of Sri Lanka's outstanding external debt (USD 52.31 billion)
- Studies that focus on gender distinctions in remittances show that when it comes to females, a majority remitted a higher proportion, ranging from 81-100% of the income earned in the country of destination. (IPS)
