Mayor Biondi led a discussion informing us that Suffolk County will be reimbursing us \$34,000 for snow removal in 2012/2013.

Mayor Biondi led a discussion advising that we will be purchasing a dump truck once we receive the reimbursement money from CHIPS.

A discussion was held regarding part time summer help in our Highway Department.

Trustee Busa led a discussion regarding security cameras possibly located at 13 different locations costing approximately \$91,000.00

Trustee Cappiello suggested we contact US Representative Peter King to discuss with him about homeland security.
