## **Waiver of Liability and Consent Form (Under 18 Years Old)**

In consideration of the services provided by RAD Bubble Sports, LLC ("RAD") and the risk of injury to my minor child due to my child's participation in the sport of bubble soccer ("the Activity"), I, \_\_\_\_\_ (the "Guardian") being a parent or legal guardian of the following individual who is under the age of 18, \_\_\_\_\_ (the "Participant") agree to the following terms and conditions. I understand that this document ("the Agreement") affects my legal rights and the legal rights of my child, and that by signing below I acknowledge that I have read and understood the disclosure of risks, voluntarily accept those risks, and agree to be bound by all terms and conditions of this agreement.

**1. General Release and Waiver of Liability.** In consideration of the services and events provided by RAD, I, on behalf of the Participant, and on behalf of myself, other parents and/or legal guardians, wards, heirs, assigns, personal representatives and next of kin (hereinafter collectively, "the Releasing Parties," "I," or "me"), **voluntarily release and forever discharge and agree not to sue** RAD, or its agents, members, managers, owners, officers, directors, principals, volunteers, participants, insurers, facility operators, lessors, successors, assigns, equipment suppliers or manufacturers, trainers, intellectual property holders, or any other persons or entities acting in any capacity on the RAD's behalf (hereinafter collectively referred to as the "Protected Parties") from liability for any claims connected with or arising from the Participant's participation in all bubble soccer related activities provided by RAD (the "Activity"), including, to the extent allowed by law, any such claims which allege negligent acts or omissions of any of the Protected Parties.

**2. Acknowledgment of Risks.** I fully understand that participation in the Activity involves both known and unanticipated dangers and risks which may result in injury to the Participant including but not limited to physical or emotional injury, economic or emotional loss, injury to personal property, and death. I understand that RAD does not require my child to participate in the Activity, but **I have chosen to allow the Participant to participate despite the aforementioned dangers and risks.** I acknowledge that this description of the risks involved in the Activity is not exhaustive, and that there are other risks, both known and unknown, which may result in injuries to the Participant. I agree to assume all related risks, both known or unknown to me, of the Participant's participation in this Activity, including travel to, from, and during this Activity.

**3. Indemnification Agreement.** I hereby agree to indemnify, defend and hold harmless RAD, its members, managers, employees, agents and representatives, and the heirs, successors and assigns thereof, from and against any and all threatened or incurred actions, claims, liabilities, obligations, suits, proceedings, damages, assessments, judgments, costs, or expenses, including without limitation reasonable attorneys' fees and expenses ("Claims"), of any kind or nature, contingent or otherwise, arising from or related to the Participant's participation in the Activity, regardless of whether the Claims are the result of the negligence or omissions of myself, RAD, its affiliates, third parties, or other participants in the Activity.

4. **Facilities.** In the event that any damage to equipment or facilities occurs as a result of the Participant's willful actions or negligence, I hereby agree to pay for any and all costs and equipment damage arising from any such willful actions or negligence.

5. **Certifications.** I hereby attest that to the best of my knowledge, the Participant does not suffer from any ailment of the heart, lung, or other medical condition or disease which may in any way hinder or impede the Participant from participation in the Activity. I acknowledge that the Participant is participating at the Participant's own risk. Furthermore, I hereby attest that the Participant will not participate in the Activity while under the influence of any drugs, alcohol, or medications which may result in impairment of the Participant's physical capacity or judgment.

6. **Publicity Release Form:** In connection with the Participant's participation in the production of any print, audio or filmed program material produced by RAD and its affiliates, I hereby grant, assign and convey to RAD all rights, titles, and interest I or the Participant may have in and to the specified program material and to any reproduction made there from. I also irrevocably authorize RAD, free of charge and without limitation, to broadcast, distribute and/or exhibit the specified program material and any reproduction made there from or any portions thereof. This also specifically includes permission for the Participant to appear in photographs or videotape of the events.

I hereby attest that I am of the age of 18 years or older, that I am the parent or legal guardian of the Participant, and that I have authority to sign this Waiver of Liability on behalf of the Participant. I have read this release of liability and assumption of risk agreement and I fully understand its terms. Further, I understand that I have given up substantial rights on my behalf and on the Participant's behalf by signing it, and that I enter into this agreement willingly, signing it freely and voluntarily without any inducement. I attest that this Agreement is unambiguous, and was entered into at arm's length without duress or coercion. I understand that I am free to decline to sign this waiver and for the Participant to not participate in the Activity.
