Services offered include: health history, physical examination, vision screenings, immunizations, dental assessments, fluoride treatments, lead screenings, developmental and mental health screenings, orthodontic screenings and referral to community providers.





Insurance Information

Medical Assistance/Medicare/Medicaid and Medicaid Expansion Programs

- QMB-Qualified Medicare Beneficiaries
- Net countable income cannot exceed 100% of the Federal Poverty Level
- Medicaid pays the Medicare Part B premium
- Medicaid pays the deductible for Medicare Part A and B and co-insurance
- The individual may be eligible for other Medicaid benefits
- SLMB-Special Low-Income Medicare Beneficiaries
- Net countable income must be more than 100% but not exceed 120% of the Federal Poverty Level
- Medicaid pays only the Medicare Part B premium
- The individual may be eligible for other Medicaid benefits
- QI-Qualifying Individuals
- Net countable income must be more than 120% but not exceed 135% of the Federal Poverty Level
- Medicaid pays only the Medicare Part B premium
- The individual is not eligible for other Medicaid benefits in the same benefit month that the individual is eligible as a Qualifying Individual

Individuals who are not disabled or under age 65 can now apply for affordable medical coverage through the expansion program started in 2014. 

You will need to fill out a one-page application form and, depending on your situation, provide original or a certified copy of your birth certificate and a second form of identification. 
They must be 65 years old or older or have a disability that is either physical or mental condition or combination of both, that is expected to last at least 12 months or longer or a terminal illness or be legally blind.


