Department Highlights

1. 17 families were visited by social workers
2. Consultation and advice provided to four women and nine kids
3. Recruited 37 new children for the new Kindergarten classes at family house and compassion house
4. Followed up on three students absentees. Feedback obtained was forwarded to the education office
5. Brought 4 children to the hospital
6. Obtained permission from the relevant authorities, around target areas, to conduct a survey with people in the community
7. Led 24 Singaporeans in their interviews of people in the community.
8. Provided 16 families with non-food support (e.g. mats, blankets, mosquito nets and tents) as part of a charity event. The items were provided to protect children, in the slums and surrounding areas, from mosquito-transmitted diseases.
9. Provided football training for both boys and girls every Saturday morning
10. Finalized job description forms, objective forms, planning format, appraisal form and guidelines for use by the social work department.
11. Trained 25 women, at Kilomet six, on child sex tourism and how to prevent it. Kilomet six was aided by APLE in this area and Riverkids will continue to work closely with them and local authorities to increase parental awareness of the vulnerability of their children to different types of child abuses.

Department Challenges


1. Organisation Related Issues:
 - Objectives of social workers not clear as yet
 - Concept of activities planning needs more development
 - Social workers need further coaching to ensure adherence to social procedures and policies
 - Shortage of colleagues
2. Community Related Issues:
 - A few parents could not spare the time to meet us
 - Other parents did not encourage their children to return to class or provided poor support in encouraging their children to return to school
 - Some families forced their children to work in trash collection so as to support the family
 - Some families moved frequently and did not inform Riverkids of their whereabouts
 - Other families made requests which are beyond Riverkids ability to help

Next Plan: (Mr. Theany, Mr. Chea, Ms Sokhim, Ms Davin, Mr. Virak)

1. Prepare for next month's visit to 16 families - 3 in ChroyChangvar, 10 in PsarToch and the remaining 3 are our project students' families.
2. Follow-up, through family visits, on absentee students
3. Meet and provide counseling to students who are often absent from class.
4. Develop weekly and monthly plans

5. Continue to recruit children for new kindergarten class
6. Complete designed forms by December 2011
