Department Summary

Please summarize your department's work this month

- Visited 34 families at Psa Touch, RailwayII, Doeum Kvet, and Samky village in order to figure out the problem and to understand their living situation.
- Provided counseling one students.
- Provided counseling eight women at training skill program.
- Followed up three students who absent at extra class and at state school.
- Visited two students at Hospital.
- Clarified six students who didn't have a birth certificate before enrolling them to state school.
- Worked with Aple's staff to follow up Ms. P. T. regarding Trafficking case.
- Provided study materials and school uniform to outside project student.

Highlights:

1. Ms. Y. S. returned to attend training skill at Friend Orgainzation again.
2. Miss. Sokkhim and Davan visited Ms. S. V. at Kunhabopha hospital.
3. Ms. M. S. R., Bootstrap program got the new job at Canadia center as a cleaner with 95\$ per month.
4. On 23 Oct 2012, Ms. Davan bought Ms. T. P. to do interview and enroll her into Bootstrap Program before she joined vocational training at Hagar.
5. Get birth certificate for 7students at Phsar Touch and Demkvet Village before send them to state school.

Challenge:

1. Ms. S. S. at Bootstrap program, she always absent in vocational training as a cooking at outside because her health not good because she abortion baby.
2. It was the problem for us while the children missed some documents, so they were difficult to attend state school, and their parents did not concern about that.
3. At the time of parenting Jew, parents didn't attend on time and wasted much time.
4. Students who moved to his home land without inform social team knew where they were.
5. Three families in Blum and Compassion house communities required help from RKF such as paying house rental and electric fee as well.

10. On 05 Nov 2012 (Davan&Sokkxim): Attended opening new class at HAGAR (Career Pathways training).
11. On 6th Nov 2012(Sokkxim&Sophea): attend in Partner Orientation meeting which provide by Social Department at RUPP.
12. On 7th Nov 2012(Sokkxim&Sambor): go to Samky village to recruit GRG.
13. On 13 to 16 Nov 2012(Davan&Sokkxim): will Attend Advance Counseling training at TPO.
14. On 20 Nov 2012 (Davan&Sokkxim): Conducted training about Domestic violence at Samky village.
15. Follow up absent students who study at state school and Riverkids class.
16. Do family visit at Blum and Compassion House to know the people who engage with Riverkids.
17. Provide counseling to women and children in Riverkids.
18. Help Ms. Soeur Kunthea to follow up the attendance of women in Bootstrap program outside Riverkids.
19. Contact with authority twice a month in case of any problem in the community such as domestic violence, trafficking or abuse.
