## Department Summary

- Ms. S.L. and her daughter moved to the new rental room.
- Recruited two kids to day care program.
- Provided Domestic Violence assistance to villagers at Psa Touch and Doeum Kvet village.
- Ms. L.C. and Ms. P.B. attended beauty salon skills program at Ly Lang shop near ToulTompong Market.
- Ms. C.R. attended sewing skills program at Sok Ly shop near SrasChhork Pagoda.
- Recruited Ms. K.S. to join (Bootstrap program) training at HAGAR class.
- Prepared transportation for six women to attend training at HAGAR and outside Riverkids.
- Visited 49 families at Psa Touchm RailwayII, Doeum Kvet, and Samky village in order to figure out their problem and to understand their living situation.
- Followed up on 19 students who were absent from extra class.
- Provided counseling for two students.
- Provide counseling for one family.
- S.V. was transferred to Kunkabopha Hospital to cure his disease and take medication for six months.

## Challenges

1. There were many new programs, so it made it difficult for the social work team to complete all tasks on time.
2. C.R.'s family has not yet moved to live in the new room and his step father is still violent.
3. When we conducted parenting sessions, a few parents didn't come on time.
4. One kid moved to his home land and did not let us know where he was going.
5. One family needed help from RKF to pay for rent house and electrical supplies.
6. 4 kids were moved to live in other places.
7. We could not complete the report on time because our team was helping to do the film and helping volunteers.
