6. Visited the 56 families at Psa Touch, Railway II, Doeum Kvet, and Samky village in order to better understand their living situation.

8. Provided counseling for 8 students.
9. Followed up with 36 students who absent from state schools and extra classes at communities such as Psa Touch, Doeum Kvet, Railway, and Samky village.
10. L.V. got a fever and transferred to the community nurse; and Ms. T. S. transferred to National Pediatric Hospital (NPH).

### Challenges

1. Miss. P. B., was absent three days from the Bootstrap program training at HAGA. She was having a problem with the group and needed to take care of her pregnant sister.
2. The Social Team is challenged to complete tasks on time, as the number of programs are too great to manage.
3. Miss. Yen Sophin decided to stop her training at Friend Organization.
4. We invited 40 families to join the meeting, but only 20 families attend the meeting at Psa Touch village.
5. There are three parents who were not respectful of the meeting start time.
6. There are four families who often move from one place to other place without notice.
7. There are two families who are less encouraged to persuade their kids to go to school.
