## Resolution 2017-017

**A RESOLUTION BY THE BOARD OF FIRE COMMISSIONERS OF PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 18. APPROVING THE INCREASE IN THE EMS LEVY AMOUNT FROM THE PREVIOUS YEAR.**

**WHEREAS,** The Board of Commissioners of Pierce County Fire Protection District No. 18 has met and considered its budget for the calendar year 2018; and,

**WHEREAS,** the districts actual levy amount from the previous year was \$610,206.52 and

**WHEREAS,** the population of this district is more than 10,000; and

**NOW, THEREFORE BE IT RESOLVED,** by the governing body of the taxing district that an increase in the regular tax levy is hereby authorized for the levy to be collected in the 2018 tax year.

The dollar amount of the increase over the actual levy amount from the previous year shall be \$4,527.74 which is a percentage increase of .74201% from the previous year. This increase is exclusive of additional revenue from new construction, improvements to property, new constructed wind turbines, any increase in the value of state assessed property, any annexation that have occurred and refunds made.
