12 x 20 ft. (Approximately) Vendor Space - \$60

24 x 20 ft. (Approximately) Food Vendor Space - \$200.00 (Each additional space \$50.00)

Please purchase enough space to accommodate your total operation.

RULES (please read carefully)

- ❖ **For Food Vendors:** All City of Canton Health Permits must be displayed.
- ❖ Vendor may bring canopy, banner, tables, chairs and extension cords (all must fit within booth space)
- ❖ Vendors are responsible for their own setup & tear down, their booth at all times, and collection and payment of state sales tax (when applicable).
- ❖ Sharing of vendor space is not allowed, unless approved.
- ❖ **All** “give away” items must be pre-approved.
- ❖ No sale of alcoholic beverages or lewd / inappropriate merchandise. This is a family festival.
- ❖ **VENDOR SET-UP: 10:00 a.m. to 5:00 p.m. ALL VENDORS MUST BE SET UP BY 5:00 p.m. on Friday, May 18.**
- ❖ **BREAKDOWN: 8:00 PM on Saturday the 19th – Friday night you may leave your products set up if you would like, there will be security working the grounds, but just know that this will be at your own risk. Any loss or theft of property is a risk you must assume. Any vendor breaking down before 8:00 PM will not be allowed to return to the Tailwind Regional Balloon Fest. NO VEHICLES ALLOWED UNTIL AFTER BALLOON GLOW**

PROMOTION: Tailwind Regional Balloon Fest will be promoted throughout Texas with additional exposure through local and regional radio, magazines, newspapers, websites, **balloonfestcanton.com** and **www.VisitCantonTX.com**, posters & flyers.
