

If either you or your intended spouse is divorced or widowed, the Re-Marriage Preparation Program is meant for you.

If you are seeking annulment of a previous marriage, you may register for the program, but *do not* set your wedding date until you have received a declaration of invalidity (annulment).

The program provides an opportunity for couples to examine their relationship, including:

- ♦ Closure of Previous Relationship
