**SUPPORTING GOOD GOVERNANCE:**

**FIRST NATIONS' COMPREHENSIVE RESOURCE AND INFORMATION MANAGEMENT AND REPORTING SYSTEMS**

**TRIPARTITE ACCOUNTABILITY FRAMEWORK: REPORTING STANDARDS LINKING OUTCOMES AND INVESTMENTS**

- Standardized Information and Financial Management Systems deployed within all First Nation Governments that strengthen Communities' administrative capacity to manage investments and to manage the data generated by these investments (social, environmental, cultural, economic, corporate...), resulting in improved compliance and reduced reporting burden.
- First Nations establish, through tripartite process (provinces/territories) a Investment Accountability Framework, including planning, evaluation and reporting standards to be followed by First Nation Governments, First Nations support organizations and institutions.
- Regional Portal: First Nations will up-load at a minimum, their CCDP, 5-year Strategic Plan and Annual Progress report including a minimum of information, with financial transparency built into Accountability Framework (planning, evaluation, reporting).

**Regional Portal:**

- First Nations will up-load at a minimum, their CCP, 5-year Strategic Plan and Annual Progress report to Citizens, including a minimum of information.
- Financial transparency built into Accountability Framework (planning, evaluation, reporting).
- Facilitate access to plans and reports by FN Citizens living in and outside of Community.
- Various levels and sources of investment directly linked to plans and measurable Outcome Statements.
- Utilization of standardized systems promotes efficiencies and effectiveness in administration.
- Data warehousing and sharing agreements will provide investors and citizens, with real time access to agreed-upon service information, via automated template population.
- Federal and Provincial Government Investors receive automated data transfers and reports as per Accountability Framework.

**Examples of Shared outcome Statements**

- Opportunities for children and youth to enhance a sense of self identity and belonging that is rooted in their First Nation values and beliefs.
- Healthy, safe and supported First Nations children, youth, families and communities.
- A comprehensive network of culturally based services in First Nations communities ranging from Prevention to Early Support to Intervention.

Healthy Child Development

- Funding Agreements relate to Comprehensive Community-driven, Nation-based strategies addressing people, land and economy and associated with Investment Streams (determinants).
- Strategies address inter-generational change, projecting fifty years into the future.
- Five year Implementation Plans lay-out activities in greater detail and include financial forecasts.
- Investment Agreements related to plan implementation negotiated on five year cycles.
- Financial Audits and progress reports are performed annually.
- Compliance audits (adherence to planning, evaluation and reporting expectations) performed as required (risk based).

Automated Annual Reports to Federal and Provincial Governments

**THE GOVERNMENT:** "Support good governance, rights and interests of Aboriginal Peoples."  
**THE PEOPLE:** "Individual, family and community well-being for First Nations and Inuit."  
**THE LAND AND ECONOMY:** "Full participation of First Nations, Métis, Non-Status Indians and Inuit individuals and communities in the economy."  
**THE NORTH:** "Self-reliance, prosperity and well-being for the people and communities of the North."

Program Architecture and Data Collection Instruments refined and associated with Broader Determinant Investment Streams for portability/comparability: National Reports based on major categories aligned with regional reports, based on regional priorities and provincial standards. G&Cs replaced with multi-year comprehensive Investment Agreements.

AANDC internal systems prepare to monitor compliance: receive Automated Annual Reports, share and analyze data.
