Acknowledgment of Risks, Injury & Obligations:

I acknowledge and understand that whilst participating in such activity:

- I may be injured, physically or mentally, or may die;
- My personal property may be lost or damaged;
- Other persons participating in such activity may cause me injury or may damage my property
- I may cause injury to other persons or damage their property
- The conditions in which the activity is conducted may vary without warning
- I may be injured or die or suffer damage to my property as a result of the negligence or breach of contract of Top Primate Academy; I hereby further indemnify Top Primate staff, it's agents or representatives or subsidiaries and or holdings from any claim of whatsoever nature resulting in any injury or loss of life.

Personal training clients are subject to all normal rules as listed in this membership pack and gym rules which can be found inside the gym.

Cancelation:

Members wanting to cancel their gym contract can and must do so in written email form. Said gym contract will be cancelled within 30 working days of email date, if said member is up to date with payments no other fees will reflect. Members willing to sign up again after cancellation may do so at their own leisure and will not be subject to sign up fees, as long as said member was not removed from Top Primate Academy for breaching terms and conditions as listed in this membership form.

Administration:

- No shoes will be allowed on the training mats at all times, unless member is wearing/participating in the boxing classes.
 - No use of shoes on kicking/punching bags and also kick/focus pads
 - Appropriate footwear for skipping/running must be on hand at all times.
 - A shirt and appropriate shorts must be worn at all times while in the facility.
 - Memberships are not refundable or transferable.
 - All weights and equipment must be put back after use.
 - Photo ID cards must be carried and shown upon request.
 - Shared gym access with a non-member will result in forfeiture of membership effective immediately.
 - Each member must respect other gym users and behave in an appropriate manner at all times.
 - Top primate Staff reserves the right to rescind the rights of members not complying with the terms and conditions of the membership.

Furthermore, if there are insufficient funds in my account to meet the obligation, you are entitled to track my account and represent the instruction for payment as soon as sufficient funds are available in my account.

Payment instructions due in December will be debited on the **1st** (date).

I/We understand that withdrawals hereby authorised will be processed through a computerised system provided by the South African Banks. I also understand that details of each withdrawal will be printed on my bank statement. Such must contain a number, which must be included in the said payment instruction and if provided to me should enable me to identify the Agreement. This number must be added to this form before the issuing of any payment instruction.
