THE MISSION OF COCOON HOUSE (THE AGENCY) IS TO FOSTER PERSONAL GROWTH AND HEALTHY RELATIONSHIPS TO STRENGTHEN AND EMPOWER AT-RISK AND HOMELESS YOUTH AND THEIR FAMILIES. TO CARRY OUT THIS MISSION COCOON HOUSE HAS DEVELOPED A CONTINUUM OF SERVICES TO SERVE HOMELESS, AT-RISK AND HIGHLY

PROGRAM: SHELTER SERVICES - THE AGENCY HAS TWO EMERGENCY SHELTERS, COCOON HOUSE CENTRAL (SINCE 1991) AND COCOON HOUSE NORTH (2006). BOTH SHELTERS OPERATE 7 DAYS A WEEK TO PROVIDE SHELTER, FOOD, INTENSIVE CASE MANAGEMENT, CHEMICAL DEPENDENCY COUNSELING, LIFE SKILLS AND ACCESS TO MEDICAL CARE AND SUPPORTIVE SERVICES FOR YOUTH AGES 13-17. THE AGENCY OPENED COCOON HOUSE EAST (2010), A 90-DAY SHELTER FOR YOUTH AGES 18-20 TO FILL A GAP IN THE REGION. THIS SHELTER OFFERS THE SAME SERVICES AS THE EMERGENCY SHELTERS WITH FOCUS ON SECURING LONG-TERM HOUSING, GAINING EMPLOYMENT, EDUCATION OR TRAINING, AND LIFE SKILLS NECESSARY TO LIVE INDEPENDENTLY. DURING THE YEAR ENDED JUNE 30, 2012, SHELTER SERVICES PROVIDED A TOTAL OF 4,184 BED NIGHTS FOR 237 YOUTH, A TOTAL OF 359 INTAKES OF WHICH 87% WERE INTO A SAFE HOUSING SITUATION.

PROGRAM: TRANSITIONAL HOUSING - COCOON COMPLEX: THE AGENCY ALSO OPERATES COCOON COMPLEX (COMPLEX) LICENSED AS A 22-BED LONG-TERM TRANSITIONAL HOUSING FACILITY DESIGNED TO HOST ALL CRITICAL SERVICES TO TEENS AGES 13-17 ON-SITE WHO HAVE NO OTHER HOUSING OPTIONS. AVAILABLE SERVICES INCLUDE INTENSIVE CASE MANAGEMENT, DRUG/ALCOHOL COUNSELING AND MENTAL HEALTH CARE, HEALTH CARE, EDUCATION SUPPORT, LIFE SKILLS TRAINING, FOOD, AND BASIC NEEDS. BY REGULATION, YOUTH CAN LIVE AT THE COMPLEX FOR UP TO 21 MONTHS AND UNTIL THEIR 18TH BIRTHDAY. DURING THE YEAR ENDED JUNE 30, 2012, 45 YOUTH CALLED COMPLEX HOME FOR A COMBINED TOTAL OF 4,354 BED NIGHTS; AT EXIT 75% OF THESE FORMERLY HOMELESS YOUNG PEOPLE MOVED ON TO SAFE, STABLE HOUSING WHILE 80% WERE IN SCHOOL, HAD A GED, OR ACHIEVED THEIR HIGH SCHOOL DIPLOMA.

PROGRAM: PREVENTION, PROJECT SAFE & OTHER: COCOON HOUSE LAUNCHED PROJECT SAFE IN 2001 FOLLOWING A THREE-YEAR PLANNING AND DEVELOPMENT EFFORT. THE PROGRAM DESIGN IS FOCUSED ON HELPING PARENTS DEVELOP SKILLS AND ATTITUDES THAT INCREASE FAMILY MANAGEMENT. THE PROJECT PROVIDES: (A) PHONE CONSULTATION TO PROVIDE EASILY ACCESSIBLE EXPERT GUIDANCE TO PARENTS, INCLUDING INFORMATION AND REFERRALS, SUPPORT AND PRACTICAL HANDS-ON ADVICE; (B) PSYCHO-EDUCATIONAL WORKSHOPS DESIGNED TO GIVE PARENTS THE INFORMATION AND SKILLS THEY NEED TO MORE EFFECTIVELY PARENT THEIR TEEN; (C) WEEKLY DROP IN SUPPORT GROUP FACILITATED BY MASTER'S LEVEL THERAPIST FOR ONGOING SUPPORT WITH THE DAILY STRUGGLES OF RAISING TEENS (D) RESOURCE INFORMATION AND PUBLICATIONS DESIGNED TO PROVIDE HANDS-ON INFORMATION TO PARENTS; AND (E) WORK WITH OTHER COMMUNITY RESOURCES (E.G. TODAY THE PROGRAM RECEIVES REFERRALS FROM A WIDE VARIETY OF ORGANIZATIONS. WAYOUT IS AN INTERACTIVE WORKSHOP FOR YOUTH AND THEIR PARENTS OR GUARDIANS. STREET OUTREACH AND ADVOCACY: THE PROGRAM IS THE ONLY OUTREACH PROGRAM FOR YOUTH AGES 13-21 IN SNOHOMISH COUNTY. FOUR ADVOCATES AND TWO OUTREACH WORKERS WORK IN TEAMS AND CONDUCT OUTREACH WHERE YOUTH ARE: IN PARKS, CAMPGROUNDS, ETC. ADVOCATES WORK WITH YOUTH TO MEET THEIR BASIC NEEDS AND REFERRAL INFORMATION.
