

# **Informed, Not Instructed**From the SENY Delegate - Panel 67

Thanks so much to all who participated in helping me prepare for my first General Service Conference. It's been an awesome process, and as I write this, I am counting down the last few days until I leave for Rye, New York. That means I've been struggling with just staying in today, and so my sponsor suggested I reread Step Three. This alcoholic still needs to remember the basics and to keep things simple.

I received a great reminder today in an e-mail from the delegate of Area 56, who is the chair of the Convention Literature Committee. She wrote: "I hope your final preparations for the Conference are going well. Just remember, they will never be perfect and they aren't supposed to be. The work of the committee is to pool our thinking and our inspiration to come up with an informed group conscience. And that means each of us just does the best we can...I am looking forward to working with you and seeing how the committee comes together. I believe that we are all there for a reason, which may not become obvious for a while, but this is the committee that is supposed to be and you are supposed to be a member. For real."

So while I have reviewed all 1,277 pages of background material, studied all the background material for my two committees, read each of the 316 questionnaires returned so far, reread chapters 6, 7, and 8 in The AA Service Manual, as well as the Concept III and IX essays and the Conference Charter, I must remind myself that this is a spiritual process and not a final exam.

I'm about to be the 34th representative of SENY who's had the honor and privilege of voting at the Conference on behalf of what's in the best interest of our Fellowship as a whole. And for that, I am most grateful.

These presentations included: the 33rd Hispanic Share-a-Day, the 37th Convención Hispana, the Hispanic liaison to the SENY 2017 Convention, CPC, Agenda, Corrections, La Viña, Accessibilities/Special Needs, Web, Public Information, and Enlace.

RSGs (GSRs) in attendance were then asked to inform

the body on group activities (tiempo para los RSGs), followed by Old Business (Puntos Pendientes) and New Business (Puntos Varios Y Sugerencias) brought to the floor for consideration, discussion, and/or vote.

Amidst this seeming cauldron of activity I felt a loving welcome suited for the return of a long lost and beloved brother or son. The reception that you gave me, full of pleasure and warmth, made me feel as if I had returned home. # **Conceptions**From the DCMC, Suffolk County

I loved the SENY Convention this year, and I especially loved the radical change in venue. Although I have struggled with change most of my life, in AA I have learned - slowly - that change is not necessarily a bad thing. When I did the walk-through with the Convention Committee two weeks before the event, I felt that there was a rustic spirituality about the place, in spite of the several issues (especially those concerning Accessibilities) that needed to be addressed.

My joy continued throughout the weekend, and the Daily Reflections meeting on Sunday morning clinched it. When John W. announced at the next SENY Committee meeting that we were going back to the Marriott next year (for a number of very good and well thought-out reasons), initially my heart sank. I pouted for a couple of minutes, but then I had my moment of clarity. These moments are one of the greatest gifts that sobriety has given me.

That moment of conception-throwing was not about change; it was about spirituality. My conception, no matter how subconscious, had been that spirituality was somehow connected to the physical environment. As I listened to our Delegate, I thought of the words he often quotes from his sponsor years ago: "Your life will get as big as the program you're willing to work".

# The 2017 General Service Conference

#### The 67th General Service Conference

The General Service Conference was established to maintain a link among all AA groups, and to help AA effectively and consistently carry its message in ways impossible for local groups to do, yet important to the fellowship. At its heart is the communication through GSR's and other elected representatives to the area's Delegate who in turn represents the area's conscience and spirit of service on questions and issues before the Conference.

The following questionnaire was prepared by our delegate John W. for Area 49's consideration, and is based on the final agenda of this year's Conference.

- **1. ARCHIVES**: Consider proposal for a new publication: *Unity in Action: Bill W.'s General Service Conference Talks,* 1951 1970 (working title)
- 2. COOPERATION WITH THE PROFESSIONAL COMMUNITY: Consider request that the title of the pamphlet "Is There an Alcoholic in the Workplace?" be changed to "Is There a Problem Drinker in the Workplace?"
- **3. FINANCE**: Consider request to add text to the pamphlet "Self-Support: Where Money and Spirituality Mix" indicating there is no dollar limit to the amount a group may contribute.
- **4. LITERATURE:** Consider request for revisions to the pamphlet "Questions and Answers on Sponsorship."
- **5. LITERATURE:** Consider request to retire the pamphlet "Too Young."
- **6. LITERATURE:** Consider requests for literature and/or language regarding safety.
- **7. LITERATURE:** Discuss request for a revision to the pamphlet "The A.A. Group."
- **8. POLICY/ADMISSIONS:** Consider a request to add a "YPAA Subcommittee" to the service structure.

#### **New Service Material Available**

The General Service Office has developed two new service pieces that are now available to the Fellowship upon request (in English, French and Spanish). Service material differs from Conference-approved literature in that it has not come about through Conference Advisory Action. It is produced when there is a need for readily available information on a specific subject. Service material reflects A.A. group experience as well as specific and timely informa tion that is subject to change.

The first new service piece is titled "Safety and A.A.: Our Common Welfare" and shares some of the experience groups have had in ensuring the safety of the group and its members. As noted in the opening of this service piece, "Safety is an important issue within A.A. — one that all groups and members can address to develop workable solutions and help keep our meetings safe based on the fundamental principles of the Fellowship."

The second service piece is an Accessibilities Checklist, designed for meetings and groups, to help determine how accessible a meeting place is and to help diminish the trials that people with access barriers may encounter. The checklist reflects the experience many groups have had in developing meeting spaces that are accessible to all alcoholics.

# Supporting Our Future: The Buck in the Basket

How does the newcomer come to learn what passing the basket is all about?

The first thing that comes to mind is what I hear in meetings: various scripted or impromptu comments such as "Give what you can but if you can't, keep coming back" and "We need you more than we need your money". In reality, even a penny in the basket will do if that's all I have to contribute today. My contribution, regardless of the amount, gives me a voice in AA and ensures it will continue to be here for the next drunk that staggers in.

There's a story about a homeless man who collected bottles so that he could contribute towards making sure that the meeting would be there for him and for others. It reminds me that the Seventh Tradition is as much about participation as it is about self-support.

Some groups in Area 49 pass the basket twice, once for group expenses and once to support AA service entities. This is one way of clarifying what the money in the basket is for. Other groups suggest to newcomers that they not contribute until they become members of AA.

When I came to the Greenwich Village Group, I saw people putting a dollar in the basket so I did too. Since then it's been suggested to me that I contribute more when I can; so now I typically put in \$2, and sometimes more. This is still far less than the cost of a drink in 1994 when I got sober, let alone now. In most of the meetings I attend, a single dollar remains the typical contribution in the basket—as if that dollar were as capable of supporting AA services today as the dollar I contributed when I came in.

Many AAs believe that in order to become truly self-supporting, we need to be able to rely on income from the Fellowship only. That "buck in the basket" is unlikely to get us there. Which made me wonder: just how long has that \$1 been the standard for contributing in the basket?

I contacted the General Service Office and told the person who answered that I was curious about when that \$1 in the basket became the standard. He passed me on to someone in GSO Archives who warmly welcomed my question, as though it were simply the most important question in the world. I was told that I would receive some material on the subject within a couple of days—and I did, a sheaf about half an inch thick! And here's what it revealed.

In 1941, Bill Wilson realized that for the first time, Alcoholic Foundation had to ask the AA groups for assistance tance rather than consider outside contributions.

Although the sale of literature had begun to produce income to help support other service activities of the Foundation, it wasn't yet enough. Two members were dispatched to travel out among the AA groups and explain the need. It was expressed in a simple message: "if each group (sends) the Foundation a sum equal to \$1 per member per year, this might eventually carry (the) office, without other assistance." I think it must have been at this time and in this way that the "buck" found its way into the basket—both as a response to that first appeal for self-support and as a symbol of our desire as AA's to take full responsibility for our own affairs.

By 1961, the \$1 plan born in 1941 had morphed into the "Birthday Plan", which was recommended to the Fellowship by the 1961 GSC as follows: "under the Plan, members contribute \$1 per year for each year of sobriety on the occasion of their A.A. anniversaries." By the following year, some delegates were even suggesting that larger groups could have "B.P. chairmen", such was the excitement at the new plan.

Now for a little math. In 1948, in a Grapevine article, Bill wrote: "the A.A. member who really meets his group responsibilities finds himself liable for about \$5 a month on the average." Of those five dollars, two were allocated for each member's share of the group's monthly operating expenses. If the "buck" of the 1950's is now worth about 25 cents, that means that today each of us would need to ensure that we contribute at least \$20 a month to the basket, just to cover the cost of our own seat in AA. And that's assuming that my share of the monthly cost of my group's operating expenses remains \$8 or less—in this age of rental costs, doubtful.

I believe that if each of us did a bit of math along these lines, the result could very well be a widespread renewal of our connection to the 7th Tradition, throughout the Fellowship. It would make it personal and real for each of us, bringing home the knowledge that "we cannot skimp when the treasurer of our group passes the hat."

It's up to each one of us to communicate the 7th Tradition to our fellow/fella AAs, in the hopes that eventually more than 40-45% of groups (on average yearly) will contribute to AA services. Greater participation will not only sustain our 12th Step work, but will expand and deepen the informed conscience of our Fellowship.






