



It's Conference Prepping Time From the SENY Delegate - Panel 67

On February 15, I received the final agenda and full background material for the 68th General Service Conference. There are 91 items across the 13 Conference committees. The background material I received was 650 pages long, plus another 92 pages of confidential information for only the Literature committee to review.

The agenda items fall into three general categories: Review, Discuss, and Consider. "Review" deals with advisory actions from previous conferences. "Discuss" falls closer to brainstorming within the particular committee. And "Consider" means a committee may vote to approve that an item be sent for consideration by the Conference as a whole. However, there is no strict definition or protocol and nothing, and nothing would prevent considering a "Review" item or reviewing a "Discuss" item.

While I thought quite a few items would be of interest to SENY members, the items that I have placed on this year's Delegate's Questionnaire are those listed on page 6 of this issue of *The Link*.

Six of these items are from Literature, the primary committee on which I sit. So I have the awesome responsibility of being one of nine people to vote on whether those items go to the full Conference for a vote.

But final responsibility and ultimate authority for all of AA World Services should reside with the groups. That's why I really hope we have active participation and a strong response to the questionnaire. I want to be sure I am informed as best as I can be when I head to the Conference.

AA - A Solution For All Generations From the SENY Area Chair

I enjoyed two YPAA workshops at Queens General Service Share-a-Day. I chose them because I have fun at YPAA events, but also because I was inspired by this year's General Service Conference (GSC) theme. I got sober in my twenties and the truth is that I feel younger now than when I came to AA in 1987. In fact, the only time I've felt old in sobriety was when a few years ago I was introduced to speak at a YPAA convention as "one of the original young people!"



It'll be interesting to read the GSC final report on the discussions this year about "a solution for all generations." I'm a registered nurse who specialized in geriatrics, so I have first-hand knowledge that there's no age limit on the devastating effects of alcoholism.

At the GSC, our delegate carries the collective group conscience of our area (Concept I). Because his job is to act in the best interest of all of AA, if he hears different perspectives which make it clear that the right thing to do is to vote another way, he'll do so (Concept III). And our delegate will then report back to us, and our informed conscience will be further developed. I'm thrilled with how this thing works!

In AA, we pass on our experience, strength, and hope. Here's some of mine: my service sponsor taught me to "always pray for the delegate." For those who pray, I invite you to join me in doing so during this incredibly busy time of year for our delegate.

The Alcoholic Who Still Suffers From a SENY Corrections Committee member

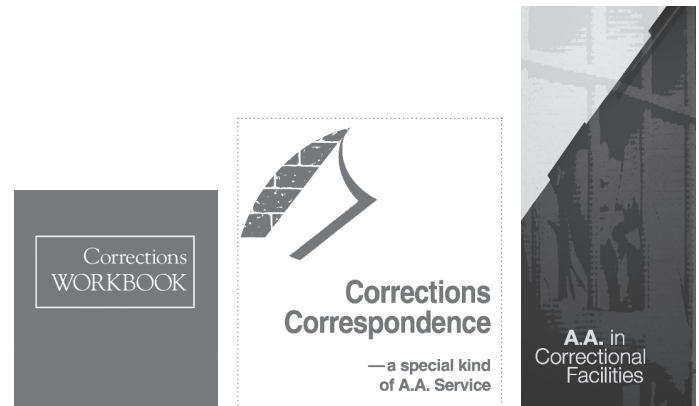
The AA Preamble states, "Our primary purpose is to stay sober and help other alcoholics to achieve sobriety". Twelfth step work has always been indispensable in my AA program. I consider it the surest way to stay away from a drink and I believe that it is God's will for me to give away what was given me. How do I find the still suffering alcoholic? Common places are AA meetings, prisons, rehabs, and detoxes. Or God may just put one into my life. Just being there for those locked up in prison holds a special place in my heart. "Your job now is to be at the place where you may be of maximum helpfulness to others, so never hesitate to go anywhere if you can be helpful."

My alcoholism brought me to prison. Throughout the time I spent incarcerated the hand of AA was always there for me. The months spent in AA "on the outside" had allowed me to get connected and acquire addresses of sober members in my home group, five of whom corresponded with me during my time "on the inside". Working the steps through the mail and continuing to work the entire program to the best of my ability allowed God to do His work, which then started my career of helping others.

Whenever I needed literature or help in re-instating a meeting at a facility, I wrote the General Service Office (GSO) and they always responded promptly. There are a number of ways to be of service to the incarcerated: take meetings into a facility (this can be some of the most rewarding AA work); sign up for prison correspondence and write with individuals who are currently locked up; volunteer to be a pre-release contact to help someone being released and planning to attend their first AA meeting "on the outside"; help support the work of Intergroup and GSO by volunteering time or funds that help support those who are still incarcerated.

Join me on the journey to be of maximum service to our fellows.

Thanks For The Nudge From the DCMC, Orange County

In the late fall of 2013, a fellow member of AA told me I wasn't doing enough for AA and invited me to the Orange County General Service meeting. Little did I know that elections for new officers would soon be taking place and when the DCMC announced the Grapevine Committee Chair, I was nudged (by a man who eventually became my service sponsor) to put my hand up. After the meeting I was thinking how grateful I was to be elected but was then told, "We had no choice, your hand was the only one up." I served for 2 years, attending spiritual breakfasts, area assemblies, conventions, etc. I even spoke on a Grapevine panel at NY State Informational Workshop and authored an article for The Link - all as a result of that nudge.

I was serving as alternate DCMC when Orange County hosted the area assembly in November 2014. My mom had just passed away and I really had no desire to attend but I did; Jane E. unknowingly nudged me into attending, having shared at a previous assembly that she too had just lost her mom. Then Alternate Delegate John W. asked me to consider being one of the theme speakers at the convention and my heart sank. I didn't answer immediately and he suggested that I think about it and get back to him. I said it would be an honor and privilege to speak.

In 2016 I was full of fear at the prospect of becoming the Orange County DCMC and decided not to seek the position, but our Delegate John W. and Chair Jane E. asked me to reconsider. Jane even offered to move the assembly to a later date so it would not be so overwhelming and assured me that help would always be there. John just looked at me with that look he has. I knew they had my back - that was the nudge I needed.

Having now served for a year as DCMC I am so grateful for all the nudges that were given me and my fellow DCMCs. We have been encouraged to attend Spiritual Breakfast's (thanks Mel), Spanish Conventions and Assemblies (thanks Tom), to take action and to do panels in particular areas like Safety in AA (thanks Scott), and workshops at Assemblies (thanks Regina), and to support county inventories (thanks Rob).

Let's continue to keep our Fellowship united by nudging our members down the road of happy destiny and growing in love and service.

About Accessibility in AA.... From the DCM, District 601

Manhattan District 601 and the SENY Committee on Accessibility/Special Needs are hosting a workshop this April 21 on the topic of Accessibility in AA.

I'll be honest: I've never considered accessibility to have much to do with me. That has recently changed. In mid-January, I suddenly had to have surgery. My surgeon said: "For two weeks, absolutely no stairs."

My A.A. world suddenly got small. I couldn't go to my home group (three flights of stairs) or to a sponsor's 10th anniversary celebration (more stairs). After describing the logistics of the recent assembly, my surgeon, advised me to stay home.

I'm currently not the able-bodied man I've always considered myself to be. And I now understand that I can go from able-bodied to dis-abled at any time.

I've quickly come to understand that accessibility in AA has everything to do with me, able-bodied or not. And not only because it has impacted me - or might again. I also have a responsibility.

We often close service meetings with the Responsibility Statement: "I am responsible, whenever anyone, anywhere reaches out for help..." I read this now and feel it asking more from me on accessibility, regardless of whether it is affecting me. I have sensed the scope of the need.

Let's look at just four need areas: hearing impairment, sight impairment, limited mobility needing a wheelchair, and low literacy (not every Accessibility issue is medical). An estimated 2,500,000 adults in New York City alone have one of those four need areas. This would be even higher after factoring in the rest of SENY and other need areas (e.g., homebound, language barriers).

Now, apply the incidence of alcoholism in the general population of 7% to the estimate of 2.5 million. That translates into 175,000 alcoholics - who may need certain assistance toward sobriety that the "average" person would not.

Of course, not every AA member can be educated for every possible accessibility scenario. But we can know more than we do now - and be of greater service overall.

That's the purpose of this workshop: To provide a forum for sharing of information and experiences. We have a terrific panel. We'll also discuss the Traditions and accessibility; two former Area 49 delegates will be on hand to assist the discussion.

The Delegate's Questionnaire (68th General Service Conference, 2018)

"Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship." – Bill W.

This is an exciting time of year when we have a direct link in shaping the future of our Fellowship. Below are items on the agenda for the 68th General Service Conference. I'm seeking your group's consideration of these items. My job is then to bring the collective conscience of SENY/Area 49 with me when I attend the Conference in April. The greater the participation, and the more groups throughout the area involved, the better informed I will be as your delegate.

On Saturday, March 3rd at the Delegate's Day of Sharing, in Manhattan, there will be presentations on these items and additional background given to help you better inform your group. Come and be an active part of this process.

At the April 8th Pre-Conference Assembly in Suffolk County, you will have the chance to share your group's conscience on these questions and leave your completed questionnaires with me. An electronic version of this questionnaire is also available at www.aaseny.org/d-q in English and Spanish. Please fill out that version if possible (it's easier for me to tabulate). You don't have to answer all the questions: your group may not have an opinion on an item. For those who cannot participate in the pre-Conference assembly, please complete the questionnaire online or return to me by mail, attn: John W., SENY Delegate, 199 Lincoln Avenue, Box 318, Bronx, NY 10454 or scan/e-mail to delegate@aaseny.org.

All questionnaires must be received by April 8, 2018. Thank you for helping me be a better informed Delegate! - John W.

1) CORRECTIONS: Consider development of a new pamphlet focused on long-term incarcerated alcoholics that are soon to be released.

Background/focus: Would it be helpful to have a new pamphlet that addresses specific issues related to long-term incarceration for members who are transitioning towards release and a sober life outside of confinement?

2) LITERATURE: Consider proposed revisions to the Big Book of *Alcoholics Anonymous*:

- a. Request to add an appendix reflecting recognition received from the Library of Congress.
- b. Request to add the A.A. Preamble and Responsibility Statement.
- c. Request to add an endnote to Bill W.'s story acknowledging co-founder, Bob S.

Background/focus: Would adding these items (one, two, or all three) strengthen our experience when using the book *Alcoholics Anonymous*? Will they enrich or enhance it? Or do they detract?

3) LITERATURE: Consider request to change the subtitle of the pamphlet "G.S.R. General Service Representative: May Be the Most Important Job in A.A."

Background/focus: Would changing the name to something such as "G.S.R. General Service Representative: the link between your group and AA as a whole" be clearer and more accurate? Would it increase service participation?

4) LITERATURE: Consider request for the development of a pamphlet for atheist and agnostic members.

Background/focus: Some feel "Many Pathways to Spirituality" doesn't sufficiently address the needs of AA members who identify as atheist, agnostic or freethinker. Should there be a new, more targeted pamphlet? If so, does the pamphlet "The God Word" published by Great Britain's General Service Office meet those needs?

5) LITERATURE: Consider request for the development of a new book combining Twelve Steps and Twelve Traditions with Twelve Concepts for World Service.

Background/focus: Would an additional book combining the essays of our 36 principles encourage more members to explore our pillars of Recovery, Unity, and Service--and generate more participation in general service?

6) LITERATURE: Consider request for the development of a new pamphlet for Spanish-speaking women alcoholics.

Background/focus: The Spanish-speaking female alcoholic has been identified as an underrepresented group in our fellowship. Should there be a new Spanish language pamphlet that addresses issues, cultural or otherwise, not covered by the pamphlet "AA for the Woman"?

7) LITERATURE: Consider request for revisions to *Living Sober*.

Background/focus: Should the section "some alcoholics require medication" be reintroduced to the book? Is that information more accessible to the newcomer in *Living Sober* versus the pamphlet *The AA member – Medication & Other Drugs*? Are there other updates to *Living Sober* that you would suggest?

8) TRUSTEES: Review proposal to reorganize the A.A. World Services and General Service Boards.

Background/focus: Should the Conference request the resignations of board directors and initiate corporate reorganization (as outlined in the Conference Charter) as a response to the legal action undertaken by AAWS in attempt to reclaim the original printer's manuscript of *Alcoholics Anonymous*.
