

#### Anonymity, the greatest safeguard AA will ever have, during the Flying Blind Period 2.0

AA will come out of COVID-19 better than ever, as long as we work our 36 spiritual principles, but we are in a second flying blind period as large segments of AA find their way for the first time in the digital world. Despite the pandemic, which SENY is the epicenter of right now, groups are sending me their competed Delegate's Questionnaires! AA groups are putting into action their love and enthusiasm for Alcoholics Anonymous.

The General Service Conference will be held virtually for the first time ever! The deadline for the Delegate's Questionnaire has been extended to May 10. The General Service Conference has been postponed to Saturday, May 16-Tuesday, May 19, 2020 for essential business, defined as the voting, by substantial unanimity for the completed slates of members of the General Service Board and the directors of the two corporate boards, A.A. World Services, Inc. and AA Grapevine, Inc. In addition, the Conference will hold the trustee elections, review board and finance reports and receive the reports of the Conference committees. The schedule will also include a general sharing session, an area delegates only meeting and member connection activities. The Conference Committees will be meeting in pre-Conference sessions from April 29 through May 13 to make decisions on reducing agenda workload using guidelines that will be developed by the trustees' Committee on the General Service Conference. These sessions will be scheduled by the Conference Committee secretaries.

Our International Conference is cancelled, but we have a crucial part of it, its theme: "Love and Tolerance is our Code", a timely reminder because we are quite sure to make mistakes during this time. We will learn (hopefully) from those mistakes and become even better at carrying this message.

One concern that has been brought to my attention is anonymity breaks at the public level: press radio, film, and as the 2013 General Service conference determined, the Internet. All our Traditions, including 11 & 12, are spiritual. Bill W., and others, wrote beautifully about the spirituality inherent in our Traditions. Our principle of anonymity is not really so much about preventing our members from being shamed; it's about more about humility and putting AA's greater good ahead of ourselves. I encourage you to read page 43 in "Alcoholics Anonymous Comes of Age". This passage was written from the perspective of a member who was at the first ever International Convention in Cleveland, where the Traditions were adopted, and when it was decided to give the General Service Conference a try.

The General Service Conference of Alcoholics Anonymous turned out to be a pretty great idea. I wonder what we'll decide to give a try next.

Almost all of us miss the intimacy and fellowship of a "real" meeting. Are the groups and the service entities hurting financially? Yes, they are, so PLEASE don't forget the 7th Tradition. Perhaps most importantly, do we have a new way to keep our sobriety intact, at least for the short haul? Yes, we do.

We have a brand-new set of tools for our toolbox; the next time disaster hits the world around us, once again we will be ready to extend the hand of A.A. To all the new pioneers of Alcoholics Anonymous: thank you!
