-2020, the year of the COVID-19 pandemic's start: What have we learned? Many of us have learned about virtual AA meetings. They're not Zoom meeting. They're AA meetings that happen to meet on Zoom, and in this way, we practice Tradition 6 (no endorsement). We've learned to pass a virtual basket for Tradition 7, because even though our group may not be paying for coffee, snacks, or rent, there are still expenses. Virtual events are not free. For example, the group's Zoom license incurs a cost, and we have our great responsibility to contribute "down the triangle" so the "Big Book" can be translated into a 72nd language, so emails can be answered at the General Service Office, and so countless other services General Service provides for the groups happen. We learned about the draw down of 4.5 million dollars from General Service's prudent reserve because contributions and literature sales went down. Info on the virtual basket is here.

We embraced the <u>AA Safety Card</u>, acknowledged that the law of the land does not end at the door of the meeting, and when we were allowed to reopen meetings, did so by complying with the public health mandates of social distancing, hand washing, masks, and <u>contact tracing</u>.

Some of the groups instituted hybrid meetings. A hybrid meeting is a face to face meeting held simultaneously with a virtual meeting, and we found information about how various groups did so on the <u>Technology in AA site</u>. We discovered meetings that have been online for decades at <u>the AA Online Intergroup</u>.

We cancelled the SENY Convention, held our first ever virtual SENY Assembly in April, our first ever virtual SENY Committee meeting in May, then the first ever virtual General Service Conference of Alcoholics Anonymous followed. Thank you for allowing me to be a "pandemic pioneer" serving as your SENY delegate for that historic event!

The International Convention, and all of the Regional Forums were cancelled for 2020, so we had a virtual celebration all Summer for the International on <u>aa.org</u>, where now one can find info on <u>the first virtual US/Canada Forums</u> December 5 and 19. On February 26-28, <u>the Northeast Regional Alcoholics Anonymous Service Assembly</u> (NERAASA) will be virtual for the first time ever.

On January 1, our new officers, and those higher on the upside-down triangle, all the way up to GSRs, start their new 2-year rotation. On January 1, I will step away from the Area (not AA!) and return for the post conference Assembly in June when we'll hear Tom's report back from the 2021 General Service Conference of Alcoholics Anonymous. The annual General Service Conference of Alcoholics Anonymous is the reason we exist as an Area. It's important to hear the voice of the groups at the five annual Area Assemblies, through the GSR of each group.

I ask that you continue being you, SENY, showing loving support for our officers-elect, Tom, JoAnn, Nisaa, Mike and Rich, those higher on the triangle, and for each other.

SENY is in good hands.

Serving as your delegate this rotation has taken me beyond my wildest dreams. You've given me opportunities to grow, change, and practice the Steps in new ways. You've been incredibly supportive to your delegate. I love you, SENY.

Aspects of Service – Rotation and Participation

Hello, members and friends! Here we are in the final month of Panel 69 in SENY, and I want to offer my deep thanks to all who have served in this rotation. I am especially grateful to the GSRs who have held true to their own Primary Purpose: to let the voices of the groups be heard (from the Area right down to the General Service Conference), and to carry information back to those same groups.

Now it is time for most of us to rotate on in service. The *AA Service Manual* has a wonderful passage to help us with this sometimes bittersweet transition. It can be found on page S-24, titled "The Principle of Rotation," and this principle even refers back to our 36 Spiritual Principles of AA." In the spirit of Tradition Twelve, it ever reminds us "to place principles before personalities."

This short passage touches on a number of values found in active rotation. It mentions sharing, growth, humility, and permission to "forego personal prestige." It also ends with an ego-deflating yet uplifting sentence: "With no AA status' at stake, we needn't compete for titles or praise – we have complete freedom to serve as we are needed."

The one word that is not mentioned in the passage is "participation," yet in many ways it is the underlying gift of both service and rotation. When we learn the Steps with our sponsors, we participate in our own recovery. When we take commitments in our home group, we participate in its health and wellbeing; and when we participate as a GSR, a DCM, a committee member or beyond, then we support Tradition Five, and AA as a whole.

Here's the ultimate reward I have received: in steady participation in service, and in rotating on to different positions, I am better able to understand the fullness of AA, the spiritual reward of helping an alcoholic on many different levels, and of truly appreciating the incredible gift of my own sobriety. So I thank you for letting me live in those three most important words:

I am responsible.

December A A History

December 1934 - Bill and Lois start attending Oxford group meetings.

December 2, 1943 - Bill Speaks to 300 at San Quentin Prison

December 10,1934 - Bill admitted to Towns Hospital, fourth time (fall of 33,' 34' in summer, midsummer and final admittance).

December 12, 1934 - Bill has his Spiritual Experience at Towns Hospital.

December 12, 1937 - Bill meets with the Rockefeller Foundation and tries to get money.

December 13, 1934 - Ebby T. visits Bill at the hospital, brought him William James's book "Varieties of Religious Experience."

December 13, 1937 - Rockland State Mental Hospital takes patients to a meeting in New Jersey.

December 1938 - Using the Oxford Groups principles, Bill closes the loopholes and changes the Six Steps into Twelve.

December 1948 - Dr. Bob's last major talk, in Detroit.

7th Tradition?!!?

As your Area Treasurer, I felt compelled to write this article due to numerous emails and phone calls to me requesting guidance on contributions. As we are all aware, this pandemic has had a significant impact on all our lives in many ways. What you may not be aware of is the impact this pandemic has had on our Service Entities below the Group level. Contributions to SENY have dropped sharply over the last three quarters compared to last year during these same periods. Since the pandemic and subsequent shut down of our Area, SENY's expenses have also dropped considerably. We have not had to dip into our prudent reserve to meet our expenses. This is due in part to lowered reimbursable expenses from our Officers and Committee Chairs and switching to the Virtual Platform to conduct business. It is also due most importantly to the Groups and Individuals who have continued to support SENY through 7th Tradition Contributions. My sincere Thanks to All of You!

My desire to inform everyone has more to do with our most prized service entity, The General Service Office and AA World Services. Our 7th Tradition Contributions to The GSO help carrying Our message of Recovery Worldwide. The GSO employs Special Workers whose job is to keep this thing going. The GSO has overhead expenses which must be paid as with any other business entity. The fact that the GSO had to draw money from their prudent reserve not once but twice in the last few months totaling 4.5 Million is alarming to me.

So, We ask "what can We as Groups and Individuals do?! I will tell you. Many Groups use the Pie Chart to determine what percentage each entity will receive. I suggest changing that pie chart and give a larger share to the GSO. No, the Pie chart is not set in stone and can be adjusted. Many Groups have not set up Virtual Baskets and the ones that have may not get the contributions needed to send out. The 2020 Final Conference Report states that it costs on average \$8.16 to service each A.A. member per year. If each individual A.A. Member contributed just \$8.16 to the GSO per year the GSO would not need to depend on literature sales to cover the difference. Last year's challenge was \$8.06 per member! Literature sales have plummeted since the Pandemic hit and have not yet recovered. Literature sales normally cover the shortage not contributed by Us. The shortfall is \$700,000 per month. Spread the word to your Groups and fellow A.A. Members that we must be fully self-supporting. What say You?


