Large & Small Springs x 2 Each	Washers x 14	Cotter Pin x 8	Rubber Cap x 2

Note: Model 301, 302, 304 do not come with Rubber Caps.

1 For Front Wheels / For Rear Wheels

2 Labels: Cotter Pin, Washer, Small Spring, Small Wheel, Washer, Small Wheel, Washer, Small Spring, Washer, Cotter Pin. Action: Bend the legs of cotter pin. Repeat on other side.

3 Action: Bend the legs of cotter pin.

4 Action: Push the Washer next to the wheel on the inside towards the end and drop in a cotter pin to hold it in place on both sides. Action: Bend the legs of cotter pin.

5 Labels: Large Axle, Cotter Pin. Action: Bend the legs of cotter pin.

6 Labels: Large Wheel, Washer, Large Spring, Washer, Large Wheel, Washer, Large Spring, Washer, Large Wheel, Washer.

7 Action: Secure both ends of the washer with cotter pin and spread cotter pin legs.

8 Action: Push Rubber Caps on at the end. NOTE: Some models do not come with rubber caps.

60-DAY LIMITED WARRANTY

Narita Trading Company, Inc., the warrantor, extends the following LIMITED WARRANTY to the original owner of its product:

1. PRODUCT AND PARTS

If within 60 days of the purchase of our product, any part or portion shall prove upon examination by the warrantor to be defective in material or workmanship, the warrantor will repair or replace such part, portion, or product at the warrantor's option.

2. CONDITIONS AND EXCEPTIONS

This warranty shall apply only when the shopping cart is assembled with reasonable care and according to the instructions furnished. Any misuse, abuse or alteration of it, any operation of it in a modified form, or any attempt to repair will void this warranty. Misuse includes, but, not limited, using the cart exceeding the weight maximum as stated on label and using the cart for purposes not intended by the warrantor.

3. SERVICE AND REPAIRS EXPENSE

Under this Limited Warranty, the warrantor will provide only a replacement shopping cart or a part thereof. The owner is responsible for all other costs. Such costs may include, but are not limited to:

- (a) Labor charges for service, removal, repair, or assembly of the shopping cart or any component part.
- (b) Shipping, delivery, handling, and administrative charges for forwarding the new shopping cart or replacement part from the warrantor and returning the claimed defective cart or part to the warrantor.
- (c) All necessary or incidental costs for any materials required for assembly of the replacement cart or part.

4. LIMITATION ON IMPLIED WARRANTIES

IMPLIED WARRANTIES, INCLUDING ANY WARRANTY OF MERCHANTABILITY IMPOSED ON THE SALE OF THIS SHOPPING CART UNDER STATE LAW, ARE LIMITED TO 60 DAYS DURATION FOR THE CART OR ANY OF ITS PARTS. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

5. CLAIM PROCEDURE

Any claim under this warranty should be initiated with the warrantor by mailing of the original purchase receipt with a return address. The owner shall also include a concise statement as to the nature of damage and its cause. All claims shall be forwarded to:
