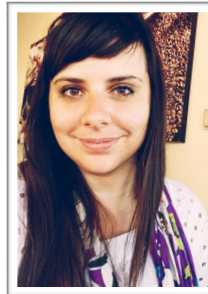

CAMBODIA PROJECTS

Coalition & Member Support

Learning Community

- ✓ Continued to **build bridges** with UN agencies, NGO partners, members, and the Royal Government of Cambodia, including the National Committee to Suppress Human Trafficking
- ✓ Visited **57 member organizations** during a nationwide member visit tour
- ✓ Trained members on various topics including National Minimum Standards, Child Protection, and Caring for Trafficking Survivors, with over **90 participants**
- ✓ Facilitated new and existing **forums** including the Economic & Sustainability Forum, Outreach Forum, and Family Forum, with 117 participants overall

Chab Dai Charter

- ✓ 44 members have now **signed** the Chab Dai Charter, of which 42 completed the **self-assessment**
- ✓ Awarded **11 charter members** with improvement grants
- ✓ Facilitated **self-care and support** trainings for 17 member organizations
- ✓ Implemented “exchange visits” for 8 participating organizations

Doorsteps

- ✓ **Trained 124 Cambodians** in leadership and project cycle management using *The 7 Habits of Highly Effective People*, and curriculum focused on financial accountability, learning to learn, livelihood development.
- ✓ Provided **8 small improvement grants** to participant’s projects in the amount of \$23,000
- ✓ Conducted an alumni meeting with 49 previous participants

Jeut Nung Dai

- ✓ Completed the **Counseling Skills Training Course** in two provinces with 32 participants
- ✓ Organized a conference on a “Cambodian Social Work Response” with more than **160 participants** from more than 40 NGOs.

CAMBODIA *Prevention & Intervention Projects*



Community Prevention

- ✓ Our Church & Community and Urban Prevention programs trained **189 community trainers** in **9 provinces** who then trained over **8,444 community members**
- ✓ Distributed **83,920** help cards with hotline numbers
- ✓ The Vietnamese Prevention program trained **15,014** community members in **3 provinces**
- ✓ Through the success of the Vietnamese Prevention Program's hotline campaign, **27 cases were reported** in 2013 alone

Community Heroes

- ✓ Trained 35 local heroes who then trained **6,535 community members** from **7 provinces**

Case Support

- ✓ Facilitated case management for **58 cases representing 77 clients**, many won in court
- ✓ Assisted in direct repatriation of **7 survivors** of trafficking in Malaysia
- ✓ Helped coordinate cases of Cambodian domestic workers, including successful repatriations for **11 survivors** from Malaysia



Story of Hope

My name is CH. M. I am the Chief of the Vietnamese Association and live in the Kampong Chhnang Province.

I attended the Awareness-Raising workshop with the Chab Dai Coalition where they showed us how traffickers approach communities. We learned about child trafficking and now we understand how to protect our children, families and communities from offenders. Last year, there was a sensitive case involving a child. As the Chief of the Vietnamese Association, I did not know who to contact for help.

After this training, I now know how to respond to such a serious situation, which has made me more effective when trying to help children and others in my community.

My Association and I would like to thank the Chab Dai Coalition for coming and educating us on how to protect ourselves, our family and our community.

Advocacy & Research

Butterfly Longitudinal Research

A longitudinal study examining the (re-)integration process for survivors of sex trafficking in Cambodia over a ten-year period. The overriding objective is to understand (re-)integration from the perspective of survivors themselves.

- ✓ In 2013, we completed our **4th year** of research (report available for download at chabdai.org)
- ✓ Disseminated research and findings locally, regionally and globally

Journey of Change Research

Examines key trends and influencing factors that have either directly or indirectly impacted counter-trafficking efforts in Cambodia since 2003.

- ✓ Using a mixed-methods approach, data was collected through a survey of 128 publications, and 11 in-depth interviews
- ✓ Report was released in June 2013 and then presented to national stakeholders in Phnom Penh (report available at chabdai.org)
- ✓ Findings indicate influencing factors in counter-trafficking efforts in Cambodia between 2003-2012 included media coverage, donor preferences, national government, research findings and Chab Dai Coalition.

“It’s time to challenge the discourse around trafficking, engage in broader discussions of intersecting issues, allow a new discourse to inform programs on the ground, and allow innovative programs to in turn inform discourse.”

INTERNATIONAL Global Learning Community

Piloted in 2011, Global Learning Community aims to document and share lessons learned across international counter-trafficking efforts through supporting, coaching, and assisting international stakeholders in multiple sectors.

Achievements in 2013 include:

- ✓ The public launch of **Freedom Collaborative**, a web application designed to increase knowledge-sharing, accountability, and inter-organizational awareness across multiple sectors involved in counter-trafficking around the globe.
- ✓ Partnership, capacity-building and knowledge exchange with over **200 partners across 29 countries**.
- ✓ Expanded engagement with the **academic sector** including independent scholars and academic institutions.
- ✓ Initial planning and steering committee development for the expansion of **Freedom Registry** into Cambodia, Costa Rica, and other partner countries.

Chab Dai Canada, UK & USA

In addition to our founding office in Cambodia, we also have national offices in the Canada, the United Kingdom and the United States.

- ✓ In the United States, **Chab Dai USA** continued implementation of the Freedom Registry, participated in local coalition-building efforts, and provided various training workshops for government offices and non-profits
- ✓ Chab Dai USA began planning for its name change, re-structuring and transition into **Chab Dai International**, planned for 2014
- ✓ **Chab Dai Canada** continued planning for the design and implementation of Freedom Registry Canada and participated in local counter-trafficking efforts in Montreal
- ✓ **Chab Dai UK** continued fundraising efforts for projects in Cambodia, and began initial discussions about the development of Freedom Registry UK

Chab Dai is committed to modeling the highest of standards in all that we do, and is therefore fully committed to fiscal transparency, accountability, and stewardship.

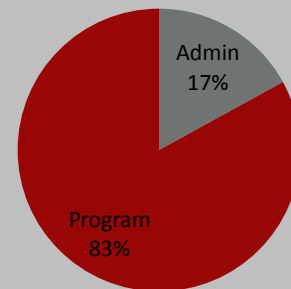

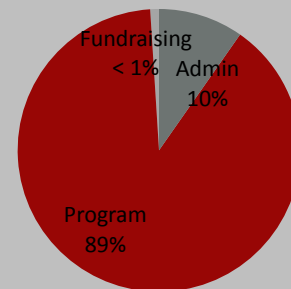

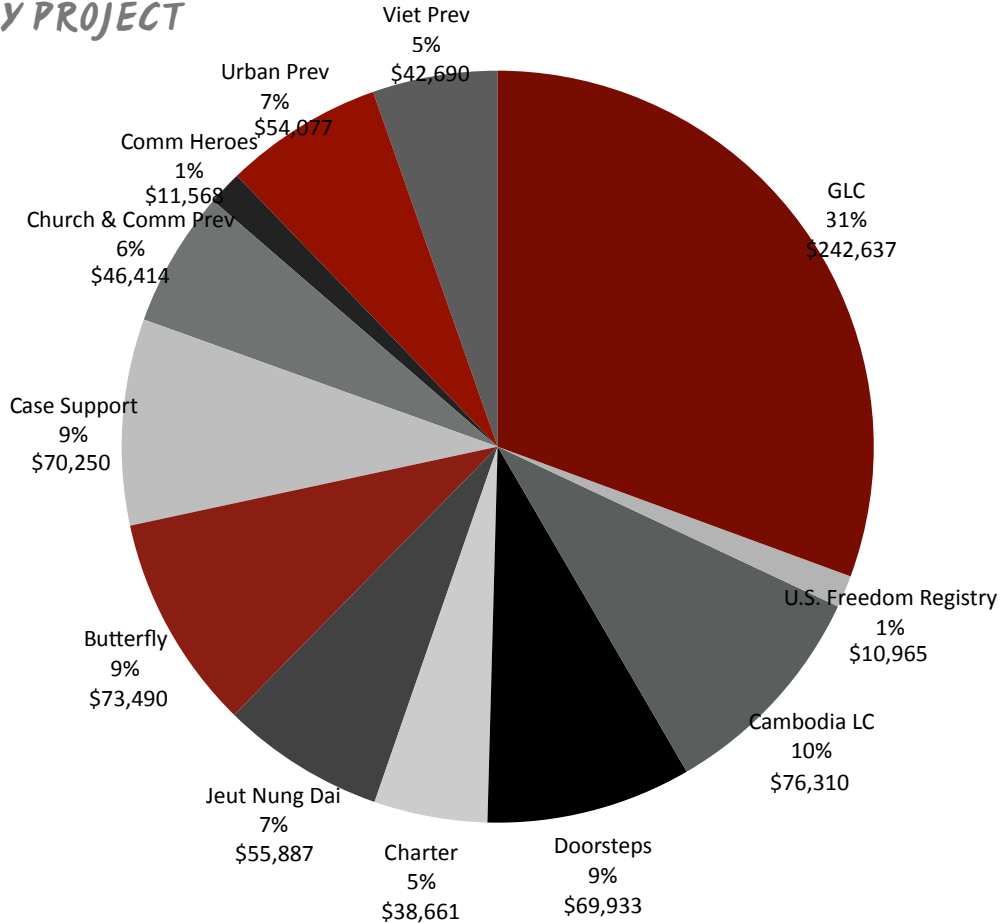
