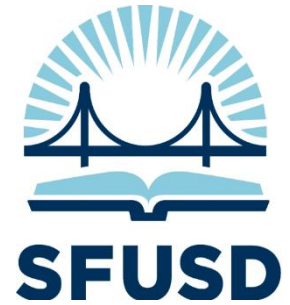

This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.
