
## ABOUT YOUR INSTRUCTOR... Mark Ziese

# ITINERARY

Day 1 (Sun) March 13 - Depart USA Depart USA

## Day 2 (Mon) March 14 - Arrive in Tel Aviv

After arriving at the Tel Aviv airport, meet your coach and driver. Visit the ruins of Old Joppa. Enjoy a refreshing walk in this biblically rich place and peer down from a 4,000-year-old ruin-mound to a strategic harbor. Transfer to your hotel overlooking the Mediterranean Sea.

## Day 3 (Tue) March 15 - Caesarea-by-the-Sea, Mt. Carmel, Megiddo

Two spectacular sites frame this day. The first is associated with the NT period, and the second, with the OT period. Caesarea-by-the-Sea was built as the imperial center for the Roman government. Its harbor, theater, and marbled streets signal the arrival of foreign occupation in the Heartland and not surprisingly, the beginning point for Christianity in the Gentile world. The second site of the day is Tel Megiddo, an ancient command post. Many battles were waged in its shadow, including those of Israelite kings and Egyptian pharaohs. Enjoy walking through the remains of these two cities that introduce the land, its history, and the challenge of its interpretation. Visit Mt. Carmel where Elijah defeated the prophets of Baal. Transfer to Tiberias for dinner and overnight.

## Day 4 (Wed) March 16 - Magdala, Chorazin, Mt. of Beatitudes, Capernaum, Primacy of Peter, Galilee boat ride

Dawn comes early at Magdala, an industrial site on the edge of the Sea of Galilee. View impressive remains that illustrate the fishing industry from the time of Christ. From Magdala, travel to nearby places linked to specific Gospel moments: the calling of the disciples, miracle feedings, the Sermon on the Mount, and the restoration of Peter. The highlight of these stops will undoubtedly center on Capernaum, the base for Jesus' Galilean ministry and the site of several miracles. With these stories in mind, board a wooden boat and personally experience the wind and the waves of Galilee's most famous sea. Dinner and overnight in Tiberias.

## Day 5 (Thur) March 17 - Nazareth

Spend a day in the rolling hills of Galilee visiting sites and people connected to early Christianity. Walk through the Church of the Annunciation, a structure built over the traditional home of Jesus. Explore Nazareth Village, a living display of lifeways in biblical times. Visit nearby Sepphoris, an opulent Galilean capital from the Roman and Byzantine Periods. Overnight in Tiberias.

## Day 6 (Fri) March 18 - Upper Jordan Valley, Bashan

Experience the beauty of the far north. Leave Galilee behind and travel to the site of Tel Dan. Here an Israelite "high place," gate complex, and fortification walls are visible. Continue to the birthplace of the Jordan River at Panias, named after the goat-god, Pan. Consider the nearby site of Caesarea Philippi where Peter declared Jesus to be "the Christ." Finally, climb into the heights of Mt. Hermon, a snowy peak that marks the highest spot in all the Heartland. From a castle built in the crusader period, take in a view to the region where Jesus was transfigured. Return to Tiberias for dinner and overnight.

## Day 7 (Sat) March 19 - Jordan Valley, Jericho, Qasr Yehud, Qumran, Dead Sea Swim

Follow the Jordan River to the desert lands of the south. Stop at the site of Jericho where the walls "came a tumblin' down." Scamper over the rocks of this mound and consider Rahab's story. Travel from here to Qasr Yehud, the place on the Jordan River traditionally linked by early Christians to John the Baptist. Overnight at the Dead Sea.

## Day 8 (Sun) March 20 - Masada, Qumran & Bethlehem

At sunrise, climb to the summit of Masada, Herod's fortress by the Dead Sea. It was used by the Zealots in the time of the First Jewish Revolt. After Masada, continue to Qumran to consider the mysterious community responsible for the Dead Sea Scrolls. Peer into one of the caves where this famous scroll material was found. Continue to Bethlehem for dinner and overnight.

## Day 9 (Mon) March 21 - Bethlehem

Rise to experience Herodium, the fortress/place/gravesite of Herod the Great. Return through the desert and appreciate the humble village of Beit Sahour, home to the Christmas shepherds. Travel further uphill to Bethlehem and visit the Church of the Nativity where Christ was born! Return to your hotel in Bethlehem for dinner and overnight.

## Day 10 (Tue) March 22 - Philistine Plain

Travel west into Philistine country. Visit the site of Beth Shemesh, a city at the center of stories connected to early Israel and the time of the Judges. Walk the Valley of Elah, a site where David once faced Goliath. Scamper through the man-made caves of Beth Guvrin, a center of life for the region in the New Testament period and beyond. Dinner and overnight in Bethlehem.

## Day 11 (Wed) March 23 - Jerusalem

Summit the Mount of Olives for a view of the Old City. Walk the Palm Sunday Road to the Garden of Gethsemane. Enter the Old City and visit the Pool of Bethesda. Walk the Via Dolorosa to the most sacred in all Christianity: the Church of the Holy Sepulchre. Here, celebrate the death, burial, and resurrection of Jesus. Dinner and overnight in Jerusalem.

## Day 12 (Thur) March 24 - Jerusalem Excavations

Begin this day visiting Haram el Sharif (the Temple Mount) and the Western Wall. Walk Jerusalem's streets and investigate the excavations at the Davidson Center. Here, aspects of Temple architecture and activity from the NT period are visible. Step back still deeper in time while exploring the City of David Excavations. Go underground and witness Jerusalem's earliest remains, including a Canaanite wall, the possible site of David's palace, and a spectacular water system (conditions permitting) that terminates in the Pool of Siloam. Dinner and overnight in Jerusalem.

## Day 13 (Fri) March 25 - Israel Museum & Free Time

Visit the Israel Museum where an enormous model of Jerusalem in the NT period reinforces our own experiences. Linger in the Shrine of the Book and witness some of the most important manuscripts of the Bible. Return to the hotel after lunch for resting, packing, and last-minute shopping. After dinner transfer to the airport for your night flight to the USA.

Day 14 (Sat) March 26 - Arrive in USA
