To report abuse 1-800-96-ABUSE MORGAN FREEMAN DINNER RAISES \$80,000 children's advocacy center



Sandestin, FL (July 3, 2012)...Forty-five guests from the local area and across the country, arrived at the home of Stephan and Lori Karian in Burnt Pine at Sandestin Golf and Beach Resort. The exclusive dinner, held in June, was prepared by renowned area chefs with the guest of honor being none other than the academy award-winning actor, Morgan Freeman.

Wine aficionados Michael and Valerie Thompson, also Sandestin residents, began organizing and hosting parties in their home that over the years has officially become the Chi Chi Miguel Throwdown to benefit numerous Gulf Coast charities. This past April, the 6th Annual Chi Chi Miguel Throwdown was comprised of numerous events which began with Emeril Lagasse sharing his culinary expertise at Lovelace Interiors in Destin, Florida.
