Individual Release and Waiver of Liability



The Individual desires to visit Chase's Mill, owned by Mill Hollow Heritage Association (MHHA), and engage in activities related to visiting the Mill. This Release and Waiver of Liability (the release) executed on (date) _____ by (print name) _____ releases the MHHA, a nonprofit corporation organized and existing under the laws of the State of New Hampshire and each of its directors, officer, employees, instructors, and volunteers.

1. Waiver and Release: I, the Visitor release and forever discharge and hold harmless MHHA and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my visit to MHHA. I understand and acknowledge that this Release discharges MHHA from any liability or claim that I may have against MHHA with respect to bodily injury, personal injury, illness, death, or property damage that may result from my visit to Chase's Mill or occurring while I am providing volunteer services.

2. Insurance: Further, I understand that MHHA does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death, or damage to my property. I expressly waive any such claim for compensation or liability on the part of MHHA beyond what may be offered freely by MHHA in the event of such injury or medical expenses incurred by me.

3. Medical Treatment: I hereby release and forever discharge MHHA from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my visit to Chase's Mill.

4. Assumption of Risk: I understand that my visit to Chase's Mill may include activities that may be hazardous to me including, but not limited to, Construction Activity in or outside of Chase's Mill involving inherently dangerous activities. As a visitor, I hereby expressly assume the risk of injury or harm from these activities and Release MHHA from all liability for injury, illness, death, or property damage resulting from my visit to Chase's Mill.

5. Other: As a Visitor, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New Hampshire. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
