If reserving prior to birth, this contract is subject to availability. Reservations are filled in the order in which they are received. A discount of 10% will be deducted from the total cost of the purchase of 6 or more lambs.

My deposit of \$200 per ewe or ram, or \$100 per wether reserved is enclosed made out to: **MXB FAMILY LIMITED PARTNERSHIP**, and I agree to pay the balance due when picking up the lambs. Delivery to locations on the West Coast can be arranged in advance, subject to a delivery fee.

To the best of our knowledge, lambs leave our ranch healthy and sound, as certified by a veterinary health certificate (optional within California but mandatory for out-of-state sales). Purchaser holds Moon Hollow Ranch and Xochi Birch harmless for any injury or mishap that may occur during transportation or for any injury, ailment, illness, and/or veterinary fees after leaving Moon Hollow Ranch. It is the purchaser's responsibility to gain the knowledge necessary to properly care for his or her lambs, however we will be happy to answer all questions regarding care to the best of our knowledge. All registerable sheep will be automatically registered with the Olde English Babydoll Southdown Sheep Registry (OEER) and/or The North American Babydoll Southdown Sheep Association (NABSSAR). If purchasing registered sheep, at delivery you will receive your registration paperwork in order to transfer ownership of your animals into your name. Note that once you have received your lambs, transfer paperwork is your responsibility, and must be submitted in the year in which the lamb was purchased.

I understand that I have the opportunity to visit the ranch to visually inspect said lamb(s), and I am accepting the lamb(s) as is. If I do not complete the purchase by July 1, 2017 without prior arrangement, I will forfeit my deposit and the lamb(s) will be available for purchase to another buyer. If the animal should not be available due to illness or death, I hold Moon Hollow Ranch and Xochi Birch harmless, and understand my deposit and payments will be returned to me within 30 days of notification. This contract constitutes the entire understanding of the parties.
