**BACKGROUND:**

These Terms and Conditions, together with all other documents referred to herein, set out the terms of use under which you may use this website, Vaadhoo.co.uk and Screens-uk.com and Markcarrphotography.com (“Our Site”). The term site shall refer to all sites singular or plural owned and run by Vaadhoo Limited. Please read these Terms and Conditions carefully and ensure that you understand them. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of Our Site. If you do not agree to comply with and be bound by these Terms and Conditions, you must stop using Our Site immediately.

**1. Definitions and Interpretation**

1.1 In these Terms and Conditions, unless the context otherwise requires, the following expressions have the following meanings:

**2. Information About Us**

  - 5.2.10 Implies any form of affiliation with Us where none exists;
  - 5.2.11 Infringes, or assists in the infringement of, the intellectual property rights (including, but not limited to, copyright, trade marks and database rights) of any other party; or
