

# Artist Application for Booth Space

The sixth annual “V&E Artwalk” will raise money and awareness for the V&E Greenline community owned trail which travels through the heart of the Vollintine Evergreen Community. The event will feature the work of artists from all over the Greater Memphis area. Artists who wish to participate will be asked to pay a small fee for booth space in addition to contributing one handmade art item to a silent auction. All proceeds from the silent auction will go to the V&E Greenline to keep the V&E Greenline attractive and useful for all to enjoy. Food, beverages and music will be present throughout the day.

This will be a large family event that is now an annual occurrence in the Midtown area. It will not only raise awareness about sustaining the V&E Greenline as an important Memphis and neighborhood asset, but also provide an outlet for local artists to gain exposure and highlight the thriving art community which exists here in our beloved Memphis area.

## Booth Space

**Booth Fee:** \$45.00 with the donation of **one handmade art item** to the silent auction or \$65.00 with no donation. Access to electricity will be an additional \$15, therefore you will pay \$60. Entry fees are nonrefundable and transferable only upon the approval of the V&E Artwalk.

In exchange for the fee payment and one submitted item, all artists will receive booth space on the V&E Greenline property. Booth space will be 10ft x 10ft. Artists will be responsible for providing their own materials for set up (such as chairs, tables and tents).

**Set Up:** Artists and vendors will be permitted to set up on the day of the event at 9:00am.
