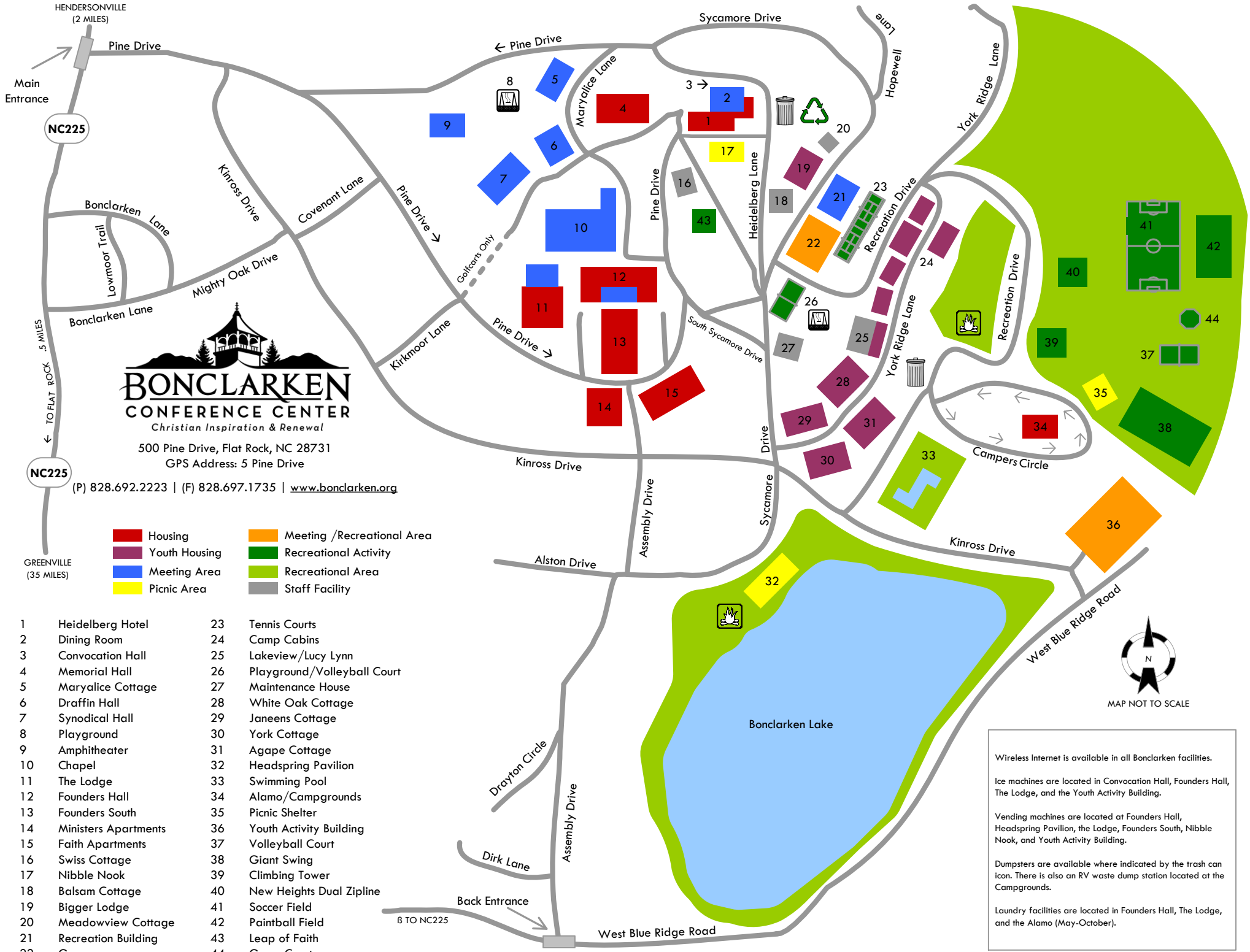

Wireless Internet is available in all Bonclarken facilities.

Ice machines are located in Convocation Hall, Founders Hall, The Lodge, and the Youth Activity Building.

Vending machines are located at Founders Hall, Headspring Pavilion, the Lodge, Founders South, Nibble Nook, and Youth Activity Building.

Dumpsters are available where indicated by the trash can icon. There is also an RV waste dump station located at the Campgrounds.

Laundry facilities are located in Founders Hall, The Lodge, and the Alamo (May-October).
