Shall defend, release, indemnify and save and hold harmless Meade County and its officers, agents and employees from any and all claims, damages, demands, liabilities, losses, actions, suits, costs, expenses, legal fees, judgments, causes of action, or other legal, equitable or administrative proceedings of any kind whatsoever, of or by anyone whomsoever, regardless of the legal theory(ies) upon which premised, which in any way result from, are connected with, or arise out of, directly or indirectly, the actions or omissions of any person or entity in connection with any use of the GIS data obtained by any person or entity; from Meade County, whether such use is authorized or unauthorized, by any person or entity, including actions or omissions of any person or entity; officers, employees, agents, representatives, invitees, subscription holders, data requestors sub-consultants, or any other individual obtaining access to the GIS data provided by Meade County.

Upon request from Meade County, use its best efforts to assist Meade County in identifying any unauthorized use of the GIS data by any person or entity that may have gained possession of the GIS data provided by the Meade County.

Acknowledge and understand that any use it makes of the GIS data that is not in compliance with this section or provided for in the Written Permission Form will cause irreparable harm and significant injury to Meade County and that Meade County may seek and obtain injunctive relief against the data requestor(s), any person or entity; for acting or threatening to engage in or facilitate the unauthorized use of the GIS data, in addition to any other equitable or legal remedies that may be available to Meade County.

That I acknowledge and understand that the GIS data is not a legally recorded map, survey, or legal document and that the GIS data may contain errors; the GIS data is for reference only and will not use or rely upon the GIS data in any other way;
