## Mutton Bustin" Rules/Entry

"Mutton Bustin" Competition will take place during the Northern Hills Ag Fest activities at the Meade County Fair on July 29th, 2016.

A complete entry form and Release Form must be turned in for a complete registration.

Only Parents or guardians will be allowed behind the chutes with the contestants. A parent/guardian will be required to assist with placement of the contestant on the animal. Parents need to be appropriately dressed when assisting with child

**Contestants must weigh less than 60 lbs (with clothes on), and be between 4 and 7 years of age.**

**Weight and age** will be strictly enforced. A Parent or Legal Guardian must sign the attached Entry form and the Release & Waiver form.

There will be two (2) qualifying classes. The first class will be ages 4-5 and the second class will be ages 6-7 years old. Age is as of the date of the event.

A qualified ride will be defined as staying on the animal for a total of 6 seconds.

Participation will be limited to a total of 15 contestants in each age division.

Riders will register to compete **on Friday, July 29<sup>th</sup>, 2016, from 4:30 pm to 5:30 pm.**

1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place will be awarded in each age division. 1<sup>st</sup> place: \$25 and a trophy, 2<sup>nd</sup> place: \$15, 3<sup>rd</sup> place: \$10. All contestants will receive a prize for participating in the "Mutton Bustin" contest.

Bring your own Helmets and Vests (a youth life vest may be used for a vest and a bicycle helmet may be used for a helmet). Participants must wear these two items of protective gear.
