NOTICE OF SPECIAL ELECTION PROPOSED REVISION TO ORDINANCE 53, AN ORDINANCE REGULATING MEDICAL CANNABIS ESTABLISHMENTS

A Special Election will be held on Tuesday, August 30th, 2022, in all the voting precincts of Meade County. The election polls will be open from seven a.m. to seven p.m. mountain time on the day of the election.

At the election, the following questions will be voted upon:

TITLE: PROPOSED REVISION TO ORDINANCE 53, AN ORDINANCE REGULATING MEDICAL CANNABIS ESTABLISHMENTS

STATE'S ATTORNEY EXPLANATION: The proposed changes to Ordinance 53, which regulates medical cannabis establishments, include three areas. First, changing how the distance requirements between medical cannabis establishments and certain other businesses or locations is determined. Changing from property line to property line, to from the entrance to a medical cannabis establishment to protected businesses. Protected businesses include school, playgrounds, churches, daycares, bars, liquor store or another medical cannabis establishment. Second, increasing the number of licenses from one (1) dispensary license to three (3) licenses for each type of medical cannabis establishment--cultivation, testing, manufacturing, and dispensary--for a total of twelve (12) licenses. Third, changes to the application process to require any application be submitted within fifteen (15) days after the license becomes available. After that initial fifteen (15) day period, the auditor may not accept applications for any type of medical cannabis establishment for any of the twelve (12) licenses available. However, any returned license would be available for application. The proposed changes would become effective after the canvas of the election returns. All other provisions of Ordinance 53 would remain as adopted.
