Wedding Contract

Dear Bride:

Thank you for entrusting us at Julio Angel Hair Studio. We take great pride in offering all of our brides the best possible service. We are honored and look forward to helping to make this special day as wonderful as you have envisioned it.

We take several steps to prepare for your special day. These steps are outlined below and the required forms are attached for your review and completion. It will be best if you begin to complete the forms as soon as possible and to get them to us so that we can ensure the appropriate service professionals are available for the dates you request.

Step 1: Wedding Services Reservation Request

We request that you make a reservation for services. This Wedding Services Packet will help you with the planning of the hair and makeup you will want as a bride and that you will want for members of your wedding party. In this packet there is a separate form for the Bride and for the wedding party. If we have not provided space for all your requests, we anticipate that you will write this in. Please forward completed forms. All appointments, questions, and changes should be directed to Alexandra Speers or Kelsea Koehler.

Step 2: Trial Appointments and Day of Wedding Appointments Scheduled

Upon receiving the completed Wedding Services Reservation Form (Form A) we will contact you. A bridal trial appointment - including hair and makeup will be scheduled. At the close of your bridal trial appointment we will confirm the services you have requested for the day of your wedding and make any requested changes to Service Request Form B, Service Request Form C and Description of Hair for Attendants Form D.

The Salon is able to accommodate catering for your special day. Our Wedding Specialist can help you with accommodating these needs.

Step 3: Julio Angel Hair Studio Wedding Services Contract Signed

After confirming the services requested and we will provide you with a total of our fees for the day of the wedding services.

Please be advised that this is an estimate only of the total fees. It is our experience that changes can occur in the services requested – particularly following the Bridal Hair and Makeup Trials and as the members of the wedding party become clearer on the exact services they are seeking. At this time, you will need to decide how the services will be paid for. They can be paid for as a group or on an individual basis. Please indicate on the Bridal Contract sheet provided how the services will be paid, any explanation, and a credit card number.
