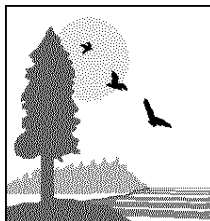

The California State Lands Commission (CSLC) will present its fourteenth biennial conference, *Prevention First 2020: An Onshore and Offshore Pollution Prevention Symposium & Technology Exhibition*, on September 29-30, 2020, at The Westin Long Beach Hotel.

Prevention First 2020 breakout sessions will feature existing and emerging issues relating to marine pollution prevention including marine terminal operations, the Marine Oil Terminal Engineering & Maintenance Standards (MOTEMS), prevention of marine invasive species introduction, onshore/offshore well abandonment and facilities decommissioning, marine debris, pipeline safety, climate change and environmental justice, spill management team and regulations update, emerging technologies, abandoned and derelict vessels and renewable energy.
