#### HISTORIC SIGNIFICANCE

This residence is located in Elgin's third historic district, the Elgin National Watch Factory Historic District, which was added in 1997. This area of town surrounds the location of the Elgin Watch factory and consists mostly of worker's cottages and vernacular houses. Elgin's Fire Barn #5 Museum is located in this district. The house is located in Julia E. Bowen's subdivision, platted in 1905. The subdivision was surveyed by W. W. Abell, one of Elgin's noted architects. This subdivision is only one square block, bounded by Regent Street on the north, South Liberty Street on the east, Bent Street on the south, and Arlington Avenue on the west. On August 31, 1910, Julia Bowen sold lot eight to Iris Perry Gibbs Preuss for \$775.00. On February 23, 1911, Iris obtained a mortgage for \$1400. The house is first listed in the 1911-12 Elgin City Directory.

Iris Perry Gibbs Preuss was born March 31, 1880. Her father, John, was born in Kentucky and her mother, Sarah, in Illinois. In 1800, the family consisted of John 55, Sarah M. 40, Emery 19, Jennie 17, Elmer 12, John R. 12, Abby 7, Maud 5, Bertha 3 and Iris, age 2 months. Iris married her first husband, Fred Taylor Gibbs, in 1898. In 1900, Iris and Fred Gibbs lived at 917 S. Center in Bloomington, Illinois with Iris' mother Sarah M. Perry and her sister, Bertha.

Fred Gibbs was born October 25, 1880 in McLean, Illinois, and died October 17, 1944 in Chicago. His father was William Taylor Gibbs, and his mother was Susan T. Gibbs. The Gibbs had a son, Earl, born in 1901, who was living in 1910 with Iris and her second husband, Alfred Preuss at 327 Ann Street in Elgin. Fred's second wife was Pearl Agnes Gibbs.

Alfred Preuss was born April 3, 1886 in Russia to Anna and Emil Preuss. His native tongue was German. The family immigrated to the United States in 1891, by 1900 living at 412 N. Winchester Avenue in Chicago. The 1900 census lists Emil, 40, Anna 39, Alfred 14, Metha 9, Wera 6 and Herbert 4. On September 11, 1909, Alfred married Iris P. Gibbs at Bethlehem Lutheran Church in Joliet, Illinois. Alfred Preuss' listed occupation in 1910 was electrician; he worked for the telephone company, in 1920 as a tester and in 1930 as a lineman. The 1930 census shows Iris and Alfred at 5253 Cartwright Avenue in Los Angeles, California. Alfred died June 1, 1974 in Glendale, California. Iris died June 24, 1968 in Los Angeles.

On April 9, 1920, Iris sold the house to Axel Swanson. Axel was born in 1889 to Emma and Robert Elton Swanson. The family immigrated in 1903 from Sweden. Axel, a naturalized citizen, worked for the Elgin National Watch Factory. In 1910, Axel, age 21, lived with his sister Lena and her husband Charles Nelson on Commonwealth Avenue in Elgin. The 1920 census shows Axel and his wife Emma living at 210 Jewett Street in Elgin with their son Robert Elton, age 1. In 1940, the family consisted of Axel 51, Emma 47, Robert Elton 21, Wesley K. 17 and Minnie Ladwig 78, Emma's mother.

Emma was born in 1892 to Herman A. and Wilhelmine (Minnie) Oehlke Ladwig. She died January 20, 1967. Axel died in 1962. Emma and Axel are buried at Bluff City Cemetery in Elgin.

In 1950, the Swansons sold 485 Arlington to Charles Joseph Pokorny. Charles, born in 1924 to Mary and Joseph Pokorny, grew up on East Main Street in Algonquin with his parents and siblings Frederich J, Francis Joseph, Charles Joseph, Joseph Wenceslaus and Margaret Ann. On January 6, 1947, he married Virginia Kaiser. Prior to the purchase of 485 Arlington, they lived at 300 Douglas Avenue in Elgin. Charles Pokorny worked for H. W. Huber Company, purveyors of coal, building materials and fireplace accessories. By 1958, Charles was vice president at H. W. Huber, and was living at 1181 Iroquois Drive in Elgin.

Herman Joseph and Loretta Krapf bought 485 Arlington in 1954. Herman was born October 21, 1914 in Dyersville, Iowa and died November 21, 1982 in Elgin. As a corporal in the U. S. Army, he fought in World War II and received a Purple Heart award. He is interred at St. Francis Cemetery in Dyersville. While in Elgin, he worked as district manager at Diamond Power Specialty Corporation. Loretta, born September 11, 1917, died in Elgin November 13, 2005.

After only three years, the Krapfs sold the house to Ronald L. and Martha J. Johnson who lived there until 1960. Ronald was a supervisor at Woodruff & Edwards Foundry on north State Street.

The next owner was Delores Swihart Hanson, a widow, who owned the house until 1966, living there until 1964, the using it as a rental property. William E. and Anna Mitchell lived there in 1965 and 1966. He was an adjuster for Farmers Insurance.

For the next ten years, Stewart and Sharon Sherman owned the house, selling in 1978 to Brett and Barbara Coleman. Both of these owners used it primarily as a rental property. Ernestine and Dean M. Huffstutler were tenants from 1968 to 1972. Dean was a strip foreman as Fastex Division.

From 1972-1977, John Thelen owned the house. It stood vacant in 1973 and 1974. From 1975-77 the occupant was John and Sandra Thelen. Brett Coleman bought it in 1977 and is listed in the directory as occupant in 1978-79, and rented it out thereafter. From 1980-81 the tenant was Len Koe Nhuk. The house was vacant from 1982-83. The tenant in 1984 was Mrs. Kay Alderete, a nurse at Sherman Hospital.

From 1985-89 Jeanette Lavender and Richard Burke, a roofer, owned and occupied 485 Arlington Avenue. In 1990, Burke sold the house to Melissa Lawrence. Occupancy was unverified from 1991-95. John Mini purchased 485 Arlington Avenue in 1995, selling it in 1997 to Diane Pace, who owned it until the current owners bought it in 2017.

Theo and Carly Gorick love the character inside and out of the home. Their guests always say how warm and inviting their home is. They love sitting on the front porch sipping coffee in the morning when it's warm outside. They take pride in their neighborhood and their home.

Carly grew up across the street; she, her parents and younger sister moved into the neighborhood on St. Patrick's Day of 1990. Her parents still live there.

Theo works in sales at Hilti, a construction products company, and Carly is an occupational therapist in School District 300.

#### ARCHITECTURAL SIGNIFICANCE

**Legal description:** Julia E. Bowens Subdivision Lot 8 Parcel number 06-24-208-009

This house is an example of the American Foursquare configuration, which enjoyed popularity from the early 1900s well into the 1920s. Actually, the design was called "box house" at the time it was built; the term "American Foursquare" was substituted later. The box house was basically a square or rectangular 2-story structure under a hipped roof, most commonly seen with a full-width hipped porch. The term "foursquare" describes the basic shape and the fact that such homes were usually nearly square and most commonly had four rooms on each story. Stylistic architectural detailing was applied to the basic shape. In 485 Arlington Avenue we see the wide eaves and horizontal banding of Prairie Style, the four-over-one windows of Arts and Crafts Style, and the round tapered porch columns of Colonial Revival Style.

#### **Accessory structures:**

The 1913 Sanborn Fire insurance Map shows a small one-story outbuilding on the northeast corner of the lot. The 1950 map shows the house at 524 Bent on the east half of the lot.

#### **ALTERATIONS**

In 1926, owners Axel and Emma Swanson divided the lot, razed the outbuilding on the north east corner of the lot, and built a second house on the east half. They continued to live at 485 Arlington, and used the new house at 524 Bent as income property until they sold it in 1949 to Gertrude Thornton.

At some point, shutters were added on the west elevation; these have since been removed.







1895 hand-drawn map excerpt


