

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to the <http://www.legacyfarmsvirginia.org> and Legacy Farms Virginia and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Legacy Farms Virginia include <http://www.legacyfarmsvirginia.org> and Legacy Farms. The Legacy Farms website is a Nonprofit green care social venture providing support services and agrarian based vocational training for adults with autism, as well as others with developmental and social challenges. site. By using the Legacy Farms website, you consent to the data practices described in this statement.

### **TRUSTe Privacy Program**

Legacy Farms is a licensee of the TRUSTe Privacy Program. TRUSTe is an independent organization whose mission is to build users' trust and confidence in the Internet by promoting the use of fair information practices. Because we want to demonstrate our commitment to your privacy, we have agreed to disclose our information practices and have our privacy practices reviewed for compliance by TRUSTe.

### **Collection of your Personal Information**

Legacy Farms may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Legacy Farms. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Legacy Farms website.

Legacy Farms encourages you to review the privacy statements of websites you choose to link to from Legacy Farms so that you can understand how those websites collect, use and share your information. Legacy Farms is not responsible for the privacy statements or other content on websites outside of the Legacy Farms website.

### **Use of your Personal Information**

Legacy Farms collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Legacy Farms may also use your personally identifiable information to inform you of other

products or services available from Legacy Farms and its affiliates. Legacy Farms may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Legacy Farms does not sell, rent or lease its customer lists to third parties.

Legacy Farms may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Legacy Farms may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Legacy Farms, and they are required to maintain the confidentiality of your information.

Legacy Farms may keep track of the websites and pages our users visit within Legacy Farms, in order to determine what Legacy Farms services are the most popular. This data is used to deliver customized content and advertising within Legacy Farms to customers whose behavior indicates that they are interested in a particular subject area.

Legacy Farms will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Legacy Farms or the site; (b) protect and defend the rights or property of Legacy Farms; and, (c) act under exigent circumstances to protect the personal safety of users of Legacy Farms, or the public.

### **Use of Cookies**

The Legacy Farms website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Legacy Farms pages, or register with Legacy Farms site or services, a cookie helps Legacy Farms to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Legacy Farms website, the information you previously provided can be retrieved, so you can easily use the Legacy Farms features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Legacy Farms services or websites you visit.

### **Security of your Personal Information**

We provide agrarian based vocational training and support services to adults with Autism Spectrum Disorder, as well as other developmental and social challenges.

Legacy Farms secures your personal information from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

### **Children Under Thirteen**

Legacy Farms does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
