

Website Privacy Policy

Purpose: This policy describes how the Chicago Urological Society (CUS) handles the information we obtain from our websites.

Policy Statement: Protecting your privacy is a matter of great importance to the Chicago Urological Society. Information we obtain and information you voluntarily provide to us through CUS websites will never be sold. We may use it to provide you with information we believe may be of interest to you, and we may share the information with third parties who provide services to us. At your request, CUS will remove from its files any contact information you provided. If you use our website to reach any of our specific software applications, additional policies may apply. We reserve the right to update this policy without notice.

Information You Provide to Us

We do not collect personally identifiable information unless you voluntarily provide it to us when utilizing a service, requesting information or logged onto one of our application systems. The Chicago Urological Society is sole owner of information obtained through our websites. We use the information to conduct business or to complete your request. Otherwise, we do not disclose personally identifiable information collected through our site unless we have your consent, or unless disclosure is otherwise permitted or required by law. Credit card transactions enabled by our website are processed through a PCI DSS certified credit card processing company. We do not collect or retain credit card information through our website. The privacy policy of the processing company controls the information they retain.

Information Gathered Automatically

When you visit CUS websites, some information such as your Internet protocol (IP) address, Internet service provider, operating system, the site from which you arrived, and the date and time of your visit may be collected automatically as part of the software operation of the website. We do not associate the data with any specific visitor. CUS is using Google Analytics, a web analytics service. Google Analytics uses cookies (small files sent to your computer) for the purposes of evaluating your use of the website, compiling reports on website activity, and providing other services related to

Internet usage. Google Analytics will not associate your IP address with any other information held by Google Analytics. You may refuse the use of cookies by selecting the appropriate settings on your browser; however doing so may prevent you from using the full functionality of the website. CUS will not associate your IP address and web usage data with any other information held by the CUS that can specifically identify you unless required to do so by law. By using this website, you consent to the processing of data about you by Google Analytics.

Protecting Personal Information

However, email messages are not secure or encrypted. When communicating via email with CUS, CUS is not responsible for the privacy of email messages in transit in either direction. While the security of your personal information is of great importance to the CUS, we cannot guarantee the security of any information you choose to disclose in email.
