First Focus Dance Workshops

Offered the weeks of June 19 and July 10, First Focus workshops are perfect for dancers 9 to 12 years of age who have just begun to have a serious, focused interest in dance training. Dancers must have completed at least one year of dedicated ballet training (DDC Ballet 1X, 2, 2X). Each day will consist of a ballet class, ballet choreography, jazz or modern class (see schedule), jazz or modern choreography and a special educational class in which dancers will learn about hair preparation, proper stretching, preparing for pointe work, sewing pointe shoes, good nutrition, proper dance etiquette, and more. Two pieces will be performed in the Friday camp performances at Mitchell Hall.

Intensive Workshops

Three weeks of Intensive Dance Workshops will be offered for intermediate level dancers (10-14 yrs, DDC Levels 2X/3/3X) and advanced level dancers (13 yrs and up, DDC Levels 4 through Advanced). Weeks 1, 2 and 3 will consist of a technique class and choreography session in ballet and a second style. Weeks 1 & 3, participants will perform at Mitchell Hall on Fridays with the camp performance. For the Week 2 workshop a demonstration will be held in the studio at 6p on the Friday. The DDC Performing Company and the Youth Dance Ensemble each have dedicated weeks of workshop for members only.

While enrollment in the full workshop is encouraged, participants may choose to register for a class only for Weeks 1 and 3. Classes will meet for 1.5 hrs Monday through Thursday (no "class only" on Fridays).

All workshops meet from 10:00 AM to 4:30 PM at the DDC studios in Newark.

A non-refundable deposit of \$50 per week is required at registration. Tuition for the workshops will increase for those registering after June 1st. Workshop tuition must be paid in full by 7 days before the first day of the workshop. Tuition amounts for enrollment before and after June 1st, 2017 are shown below for DDC members and non-members including discounts for multiple weeks.

The "Class Only" rate is \$100 mem/ \$110 non-mem per class per week for Monday through Thursday classes.
