Once your offer is made, you can choose to be paid in E-Cash or Trade:

- **30% E-Cash** – paid via PayPal within 3 business days after you accept your offer.
- **50% Trade** – paid via Greene Street Trade Card as soon as you come into the store to claim this payment.

(date)**POLICY AGREEMENT:**

All of our policies are important; however, we have noted several pertinent policies in **BOLD** below. Please read the entire Policy Agreement, initial each of the important terms below, and sign fully at the end.

- **Greene Street must accept 10 pieces to start a buy/trade contract. Exceptions may be made for designer items.**
- **Greene Street will notify you via text on or before your "Offer Deadline" (noted above, typically within 7 days) to let you know that your offer is ready.**
- **Once you receive your text message, you must call or visit the store to accept or decline your offer. If for any reason you missed your text message, it is important to call the store on or before the above date to ensure that your items were processed and to accept or decline your offer. The Offer Deadline is the LAST DAY to pick up your items. Unclaimed items not picked up after this date will immediately be put onto the sales floor and will not be returned to you. You may still claim your offer payment.**
- **Items will be pre-screened at Drop-Off, and some or all of your items may be further passed-on at the time of pricing. The Offer Deadline is the LAST DAY to pick up these items.**
- **You, the "Seller", warrant that you are over 18 and that you have legal title to and are in legal possession of all items that you are selling.**
- **High End Items – If the Seller is consigning item(s) originally retailing over \$500+ each, you may request a High End Form from the intake person at drop-off.**
- **Greene Street does not negotiate pricing and items are priced at our discretion according to fair market value.**
- **Items priced \$200+ will be consigned for 60 days at 50% or more commission. Ask a Greene Street associate for details.**
- **Unsold items priced at \$200+ may be reclaimed in person, on or up to five days before the 60 day Claim Date; otherwise they become property of Greene Street.**

- 30% and 50% Offers are based on Greene Street retail pricing.
- Offers must be accepted or declined in full. An itemized list will not be printed or sent.
- Once your payment method (buy or trade) is accepted and processed, the payment method cannot be changed. Please select carefully.
- Once you accept your offer, all accepted items immediately become property of Greene Street.
- If the Seller chooses to Pick Up passed-on items, the items must be picked up by the Offer Deadline. Unclaimed passed-on items become property of Greene Street immediately after this date and will not be returned to you.
- If both Buy and Trade options are declined by the Seller, all items must be picked up by the Offer Deadline. Unclaimed passed-on items become property of Greene Street immediately after this date and will not be returned to you.
- Greene Street does not accept faux designer, imposter or replica goods, and if Greene Street is unable to verify the authenticity of these item(s), they will be passed-on. Receipts and/or other documents may be provided by the Seller. Greene Street reserves the right to refuse a faux item at any time.
- Should the Seller accept the 30% E-Cash offer, PayPal payment will be made within 3 business days (M-F, 9am-5pm). PayPal processing may take up to an additional 1-2 business days to process.
- Should the Seller accept the 50% Trade offer, a Greene Street Trade Card (equivalent to store credit) will be issued. Cards may be claimed in person at the location of drop-off ONLY.
- 50% Trade Cards may be redeemed at the location of Drop-Off ONLY at this time.
- **High End Items – If you (the Seller) are consigning item(s) originally retailing over \$500+ each, you may request a High End Form** from the intake person at drop-off. This form will allow you to provide additional information regarding your high end items and will allow you the option of receiving a phone call for price approval on these items. If you decline the price on a high-end item, Greene Street will do our best to work with you; however, if we are unable to come to an agreed price, we will happily pull the item from your contract and set it aside for you.
 - **If item is valued OVER \$200** it will be consigned for 60 days; If you opt for a call, you will be called to confirm pricing. If we are unable to reach you via phone, we will contact you via email. If we do not hear from you within 7 days of emailing you to verify pricing, Greene Street will assume that you agree with our pricing and your item(s) will be put out for sale.
 - **If item is valued UNDER \$200** it will be part of your buy/trade offer and you will **NOT** be contacted separately. You must call on your Offer Deadline if you do not receive your “offer is ready” text from us before that time.

Consignment – items priced \$200 or more:

- Items priced by Greene Street at \$200+ will be **consigned** for 60 days at the following commissions:
 - 50% - \$200 - 499.99
 - 60% - \$500 - 2499.99
 - 70% - \$2,500 and up
- Payment for all sold, consigned items will be made within 7 days after each item selling.
- The last day of the 60 day consignment contract period is called the Claim Date. If you wish, you may reclaim unsold items ON or up to 5 days BEFORE the Claim Date. Unsold, unclaimed items become property of Greene Street immediately after the Claim Date. If you wish to reclaim unsold items, you are responsible for reclaiming in person, and for retrieving those items from the sales floor. Staff will NOT pull items for you. You will not be notified when your Claim Date is approaching – we recommend you put this date on your calendar and call prior to reclaiming to check on the status of your unsold item(s).
- Greene Street is NOT responsible for missing, lost, stolen or damaged consigned items.
- Payment for all consigned items will be **paid via PayPal only**.
- If your PayPal email address changes, it is important to notify the store immediately to ensure you are paid correctly.
