# **Constitutional Amendment 2**

Do you want to amend the Missouri Constitution to:

allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators;

restrict sports betting to individuals physically located in the state and over the age of 21;

allow license fees prescribed by the Commission and a 10% wagering tax on revenues received to be appropriated for education after expenses incurred by the Commission and required funding of the Compulsive Gambling Prevention Fund; and

allow for the general assembly to enact laws consistent with this amendment?

State governmental entities estimate onetime costs of \$660,000, ongoing annual costs of at least \$5.2 million, and initial license fee revenue of \$11.75 million. Because the proposal allows for deductions against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually. Local governments estimate unknown revenue.

## **Constitutional Amendment 3**

Do you want to amend the Missouri Constitution to:

establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid;

remove Missouri's ban on abortion;

allow regulation of reproductive health care to improve or maintain the health of the patient;

require the government not to discriminate, in government programs, funding, and other activities, against persons providing or obtaining reproductive health care; and

allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman?

State governmental entities estimate no costs or savings, but unknown impact. Local governmental entities estimate costs of at least \$51,000 annually in reduced tax revenues. Opponents estimate a potentially significant loss to state revenue.

# **Constitutional Amendment 5**

Do you want to amend the Missouri Constitution to:

allow the Missouri Gaming Commission to issue one additional gambling boat license to operate on the portion of the Osage River from the Missouri River to the Bagnell Dam;

require the prescribed location shall include artificial spaces that contain water and are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency; and

require all state revenues derived from the issuance of the gambling boat license shall be appropriated to early-childhood literacy programs in public institutions of elementary education?

State governmental entities estimate one-time costs of \$763,000, ongoing costs of \$2.2 million annually, initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually, and annual gaming tax revenue of \$14.3 million. Local governments estimate unknown revenue.

#### **Constitutional Amendment 6**

Shall the Missouri Constitution be amended to provide that the administration of justice shall include the levying of costs and fees to support salaries and benefits for certain current and former law enforcement personnel?

State and local governmental entities estimate an unknown fiscal impact.

## **Constitutional Amendment 7**

Shall the Missouri Constitution be amended to:

Make the Constitution consistent with state law by only allowing citizens of the United States to vote;

Prohibit the ranking of candidates by limiting voters to a single vote per candidate or issue; and

Require the plurality winner of a political party primary to be the single candidate at a general election?

State and local governmental entities estimate no costs or savings.

## **Propostion A**

Do you want to amend Missouri law to:

increase minimum wage January 1, 2025 to \$13.75 per hour, increasing \$1.25 per hour each year until 2026, when the minimum wage would be \$15.00 per hour;

adjust minimum wage based on changes in the Consumer Price Index each January beginning in 2027;

require all employers to provide one hour of paid sick leave for every thirty hours worked;

allow the Department of Labor and Industrial Relations to provide oversight and enforcement; and

exempt governmental entities, political subdivisions, school districts and education institutions?

State governmental entities estimate one-time costs ranging from \$0 to \$53,000, and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. State and local government tax revenue could change by an unknown annual amount depending on business decisions.

## **Children's Services Fund**

Shall Platte County, solely for the purpose of establishing a community children's services fund for the purpose of providing services to protect the well-being and safety of children and youth nineteen years of age or less and to strengthen families, be authorized to levy a sales tax of one-quarter of one cent in Platte County?

## **MCC** Attachment

Shall the Platte County R-III School District become a part of and be attached to The Junior College District of Metropolitan Kansas City, Missouri (also known as "Metropolitan Community College") effective the 21st day of November, 2024? If this proposition is approved, the overall tax levy in Platte County R-III School District will increase by Metropolitan Community College's tax levy of \$ Seventeen and Eighty-one Hundredths Cents (\$0.1780) per \$100 of assessed valuation and all residents of the school district will be eligible for reduced Metropolitan Community College tuition at the in-district rate for general education and work force training.

#### **Revenue Bonds**

Shall the City of Platte City, Missouri, issue its combined waterworks and sewerage system revenue bonds in the amount of \$24,000,000 for the purpose of improving, rehabilitating, repairing, constructing, equipping and extending the combined waterworks and sewerage system of said City, including without limitation (a) rehabilitation, repair, replacement and improvements to all components of the Wastewater Treatment Plant including stabilization of the river bank to prevent damage and flooding of the plant and the main sanitary sewer interceptors, (b) repair, replacement, rehabilitation, and improvements to the wastewater collection system including collection lines, manholes, flowmeters, system sensors and controls, order control devices, lift stations and other components of the wastewater collection system, and (c) the acquisition of any necessary rights-of-way, the cost of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the City from the operation of its combined waterworks and sewerage system, including all future improvements and extensions thereto?

#### Sales Tax

Shall the city of Weatherby Lake impose a city sales tax of one percent (1%)?

#### **Use Tax**

Shall the City of Weatherby Lake impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax rate is not approved by the voters, repealed, reduced, or raised by voter approval, the local use tax rate shall also be not approved, repealed, reduced, or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out-of-state vendors do not in total exceed two thousand dollars in any calendar year.
