OUR MISSION IS TO PROVIDE EMPLOYERS WITH SKILLED WORKERS, PRIMARILY MEN FROM COMMUNITIES OF COLOR IN THE TWIN CITIES AREA, BY TRAINING UNDER AND UNEMPLOYED ADULTS FOR SKILLED JOBS THAT PAY A LIVING WAGE OF AT LEAST \$20,000 ANNUALLY.

WE OFFER MORE THAN 29 COURSES IN FOUR KEY AREAS: PERSONAL EMPOWERMENT AND SOFT SKILLS DEVELOPMENT, OCCUPATIONAL DEVELOPMENT, ACADEMIC DEVELOPMENT AND JOB-SEARCH SKILLS DEVELOPMENT. IN 2008, WE PROVIDED EMPLOYMENT READINESS AND PERSONAL SKILL TRAINING TO 640 MEN AND WOMEN THROUGH THE CORE PROGRAM. IN ADDITION, 60 PARTIPANTS OBTAINED FINAL PLACEMENT JOBS PAYING AN AVERAGE OF \$24,744 ANNUALLY PLUS BENEFITS AND A CAREER PATH. THIS IS A 479 PERCENT INCREASE OVER THEIR PRE-PROGRAM INCOME.
