B. Prior to each shipment under this license, Premier Automotive Export, Ltd. must obtain the following statement in writing from the authorized diplomatic mission: "The undersigned understand and will comply with the terms and conditions of this license." This statement must be signed by an individual who is legally authorized to obligate authorized diplomatic mission in this matter. Provide this statement to Department of Commerce via SNAP-R.

C. All items shall remain in the possession of the authorized diplomatic missions or their staff and households at all times and must be destroyed (prior to their departure from Cuba) or removed from Cuba (upon their departure from Cuba) by the authorized diplomatic missions or their staff and households.
