1. Call To Order - 9:05 am
2. Alderman Ken's Report - Five Star Senior Center 13th Annual Summer Cool Down Luncheon will be on Wednesday, July 13th, lunch at Noon. Several complaints about cars not stopping at stop signs. Lemp & Sidney and Cherokee & Compton are the worse in the City. All of the 9th Ward City Parks will get new cobra lights. Enhanced Lighting will be on the agenda next year when there is more information available. Cameras in Real Time Policing will be installed at Cherokee & Jefferson and Jefferson and Gravois. The police substation at Benton Park is dead, not enough money to keep it going.
