

GolfStatus Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

VOID WHERE PROHIBITED.

(1) Description of Sweepstakes: GolfStatus (the Sponsor) offers various sweepstakes (“Promotions” or “Promotion”) as part of its service offering and will award prizes via a random selection from eligible entrants. Each Promotion will run for a period of time (“Promotion Period”) specified in, or associated with, each entry. By participating in a Promotion, each entrant unconditionally accepts and agrees to comply with and abide by the Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. By participating in a Promotion, participants agree to release, discharge and hold harmless employees, officers and directors of GolfStatus, its advertising, promotional, fulfillment and marketing agencies, (collectively “Promotion Entities”) from any and all damages whether direct or indirect, which may be due to or arise out of participation in a Promotion or any portion thereof, or the acceptance, use/misuse or possession of prizes.

(2) Eligibility: GolfStatus Promotions are open only to legal residents of the United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Void where prohibited by law, rule or regulation. All federal, state and local laws and regulations apply.

(3) How to Participate: Entries for Promotions can be earned using the GolfStatus mobile applications, or by other methods specified in a Promotion’s documentation. Qualification for Promotions requires redemption or acceptance of a Promotion entry, completion of all steps identified in the corresponding entry confirmation email or other Promotion documentation accompanying the redemption (collectively “Promotion Documentation”), and agreement to Sponsor’s Terms of Use, which are available at

Entries that are incomplete, late, lost, postage due, mutilated, illegible or contain irregular or invalid information, or are corrupted in any way are void and will not be eligible.

(4) Prize: The number of winners and the type of prizes are specified for each Promotion. The odds of winning depend upon the number of eligible entries received.

(5) Winner Selection: Winners will be randomly selected in a drawing conducted on or about the date specified in Promotion Documentation. Winners will be contacted by the e-mail address provided in their GolfStatus profile and may be asked to confirm prize acceptance and the completion of a W9. The potential winner may be required to provide completed W9 within five (5) days of prize notification. Failure to respond as requested within this period of time will result in disqualification and forfeiture of the prize. At Sponsors sole discretion an alternate winner may be selected. Any unclaimed prize will NOT be awarded.

Entrants grant Sponsor the right to use and publish winners proper name and State of residence online in connection with a Promotion. Acceptance of a prize constitutes permission for Sponsor to use winners name and likeness solely for advertising and promotional purposes as Sponsor so determines without notice or further compensation, except where prohibited by law. Prize recipient shall not be permitted to (a) replace his/her designated prize with another prize or item (b) redeem the prize for cash or (c) transfer or assign his/her designated prize to another person. All federal, state, local, and other taxes on prizes are the sole responsibility of the applicable winner.

(6) General: All decisions of the Sponsor in any matter relating to a Promotion shall be binding and final. Sponsor is not responsible for technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware, software, or web site. Sponsor is not responsible for lost, interrupted or unavailable network server or other connections, miscommunications, failed telephone or computer or telephone transmissions or technical failure, jumbled, scrambled or misdirected transmissions, late, lost, misdirected or postage due mail, for incorrect or inaccurate entry information, howsoever caused, or other error of any kind whether human, mechanical or electronic. Entrants found tampering with or abusing any aspect of a promotion, as solely determined by the judges, will be disqualified. If disqualified for any of the above abuses, Sponsor reserves the right to terminate entrants eligibility to participate in a promotion. Any attempt by any person to

deliberately undermine the legitimate operation of a promotion may be in violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsors failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right to terminate, cancel, suspend and/or modify a promotion, if any fraud, virus or other technical problem corrupts the administration, security, or proper play of a promotion, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award prizes at random from among the eligible entries received up to the time of the impairment. The Promotion and the rights and obligations of Sponsor and entrants will be governed by and controlled by the laws of the State of Nebraska, applicable to contracts made and performed therein without reference to the applicable choice of law provisions. All actions, proceedings or litigation relating hereto will be instituted and prosecuted, without resort to any form of class action, solely within the state courts of Nebraska and federal courts located within such state and county with respect to any action, dispute or other matter pertaining to or arising out of a Promotion. In the event any provision of these Official Rules will be held to be unenforceable, these Official Rules will continue in full force and effect without such provision.
