

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.shejustknows.com and SHE JUST KNOWS LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to SHE JUST KNOWS LLC include www.shejustknows.com and She Just Knows. The She Just Knows website is a Consultation site. By using the She Just Knows website, you consent to the data practices described in this statement.

Collection of your Personal Information

She Just Knows may collect personally identifiable information, such as your:

- Name
- E-mail Address

She Just Knows encourages you to review the privacy statements of websites you choose to link to from She Just Knows so that you can understand how those websites collect, use and share your information. She Just Knows is not responsible for the privacy statements or other content on websites outside of the She Just Knows website.

Use of your Personal Information

She Just Knows collects and uses your personal information to operate its website(s) and deliver the services you have requested.

She Just Knows may also use your personally identifiable information to inform you of other products or services available from She Just Knows and its affiliates. She Just Knows may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

She Just Knows does not sell, rent or lease its customer lists to third parties.

She Just Knows may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to She Just Knows, and they are required to maintain the confidentiality of your information.

She Just Knows may keep track of the websites and pages our users visit within She Just Knows, in order to determine what She Just Knows services are the most popular. This data is used to deliver customized content and advertising within She Just Knows to customers whose behavior indicates that they are interested in a particular subject area.

She Just Knows will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on She Just Knows or the site; (b) protect and defend the

rights or property of She Just Knows; and, (c) act under exigent circumstances to protect the personal safety of users of She Just Knows, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by She Just Knows. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the She Just Knows website.

Use of Cookies

The She Just Knows website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize She Just Knows pages, or register with She Just Knows site or services, a cookie helps She Just Knows to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same She Just Knows website, the information you previously provided can be retrieved, so you can easily use the She Just Knows features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the She Just Knows services or websites you visit.
