Dear Friends of Lincoln Child Center,

This year, Lincoln is celebrating its 130th year of service to children and families in the greater Bay Area. As I reflect on my last seven years at Lincoln, I am continuously amazed by both the longevity of this organization, and even more, the fact that Lincoln has flourished despite an ever-changing landscape in the nonprofit world. This could not have happened without the thousands of volunteers, donors and supporters like you. Today, in 2013, Lincoln Child Center (LCC) continues to strengthen families and build strong futures for children and youth throughout the Bay Area. This past year, our programs impacted thousands of children who may not have been helped without your support.

In this past year, Lincoln has made some big decisions regarding our future – the sale of our Lincoln Avenue campus was finalized, and a plan for moving our operations to West Oakland, where Lincoln originated, was solidified. This decision, certainly not an easy one, came after many of our programs had been transformed into school and community-based services that are focused in the places where those we serve are living. To accomplish our ambitious goals and to reach a better understanding of young people’s struggles, we must be accessible to them. Additionally, it is an opportunity for Lincoln Child Center to stretch and grow, and become the organization that serves as a resource hub for the surrounding community. As we look to serve children and families before they reach the need for government support, to reduce the effects of poverty, the trauma of community violence, and the lack of access to health and mental health care, Lincoln depends on its wide range of supporters to meet this challenge.

Lincoln has continued to make an impact through expansion of several programs. Our Project Permanence program, serving children and youth transitioning into a permanent home is serving foster youth and youth returning home from the Juvenile Justice Center. We have seen great success, with close to 90% of youth served still with their families six months after leaving the program. Lincoln’s truancy prevention program has also grown this year, serving 60 youth and its outcomes are remarkable – 70% of youth have improved attendance within three months of being in the program. We also launched our EXCEL services, which provide individual support to students with disabilities in their schools, reducing the amount of disruption to their education. These are just a few examples of how Lincoln is transforming and responding to effectively meet the current needs of children and youth in need.

While the team here at Lincoln has seen many success stories, the need to keep moving forward, innovate and expand our services still remains urgent. The journey is still long to create a healthy and equitable future for our children. As we prepare to celebrate 130 years of history, we are excited at what the next 130 years holds for Lincoln. Thank you for continuing to make a difference with every dollar you provide, and for making a commitment to see our children and their families thrive.

## FY 2011-2012 REVIEW

As we examine goals set in our 2010-15 Strategic Vision, Lincoln Child Center's leadership continues to determine priorities based on overarching questions:

- Does it strengthen families' ability to stay together or reunify?
- Does it help children and youth graduate from high school?
- Does it improve children's opportunity to grow up healthy?
- Does it further the goal of increasing place-based services that are accessible to children and families in their neighborhood?

2011-12 internal momentum facilitated significant shifts in LCC's service mix as a result of our intentional **focus on expansion of early intervention and prevention programs** based in communities and area schools.

**Early Intervention (EI) programming rose to 62% of our entire service mix by the end of FY12 from 30% at the end of FY10 - two years earlier. Prevention services rose to 9% from 5% during the same time period.**

Lincoln's 2011-12 program growth included:

- School Engagement Program which focuses on reducing truancy throughout Alameda County
- The establishment and expansion of two Youth Development Programs (CEO Youth and Freedom School)
- In-School special education services that focus on early intervention

We will regularly evaluate our methods for efficacy and relevance to achieve positive outcomes for the children, youth, and families we serve.

**TEAM-BASED AND INTEGRATED CARE** We are committed to providing an array of services based on the unique needs of children, youth, and families that embrace a team approach to service provision. We value the richness and diversity gained by the multiple perspectives of care team members, including family members, program staff, and community partners.

**EARLY INTERVENTION AND PREVENTION** We are committed to providing early intervention and prevention services that work toward strengthening families and communities to support resiliency, stability, independence, and growth.

**88%** of youth in HOPE Alameda showed improvement in academic performance per parent report.

**98%** of Kinship children are remaining in a living situation with a kin caregiver or returned to parents.

**85%** of youth in HOPE Contra Costa demonstrated improvement in attendance per parent report.

**89%** of Therapeutic Behavioral Services clients demonstrated an increase in positive and social behaviors after leaving the program.

**94%** of parents with children in the Early Childhood Mental Health Consultation Program indicated that they have an increased ability to engage with their child's teachers.

**61%** of students from Conyes Academy improved their reading by at least 1 grade level during the school year.

**79%** of School Engagement students demonstrated improvement in school attendance

In Lincoln's Oakland Freedom Schools, student participants, ages 5 to 7, demonstrated gains in positive racial attitudes and problem solving skills. Students ages 8-16 had higher scores on attitudes towards African American culture, and their desire to participate in social action.

**97%** of Project Permanence students remained in permanent placement six months post-discharge.

**100%** of Therapeutic Behavioral Services clients remained stable in current placements or were able to step down to less restrictive levels of care.

**70%** of CEO Youth students have **75%** or better attendance this school year.

**97%** of parents with children in the Early Childhood Mental Health Consultation Program reported that they have an increased awareness and access to support services that help their child reach educational and developmental milestones.

**INTENSIVE SERVICES** Lincoln's intensive services programs provide stability and treatment to the most vulnerable and behaviorally challenged children and their families. With the philosophy that every child deserves the chance to succeed, Lincoln maintains a policy of taking any child referred to Lincoln whose educational and mental health needs can be met by our programs.

**EARLY INTERVENTION** We are committed to identifying ways to intervene early. Our school-based mental health programs, wrap-around services, school engagement, and alternative middle school support services focus on stabilizing children and youth in their schools and communities before more intensive services are needed.

**PREVENTION IN COMMUNITIES** Lincoln's prevention services are the foundation of our continuum of care. We are broadening and deepening services in communities of need to make an impact before families find themselves in crisis.
