Instructions

Tourist 'TR' Single Entry Visa

Updated: 14/07/2017

A Tourist Visa allows you to stay up to 60 days in Thailand, starting from the day of entry into Thailand.

- 1. The application from must be completed and submitted together with the following:
 - Original Passport which must be in order and valid for AT LEAST 6 months, beyond the proposed date of entry into Thailand.
 - o 1 recent passport sized photograph (3.5x4.5cm).
 - o Flight itinerary or e-ticket entering Thailand.
 - o If you are not an Australian Citizen, proof of Australian Electronic Visa (VEVO) or Visa Grant Letter is required. The date of printing must be within three weeks of the application date.
 - o Application Form A (completed and signed by the applicant).
 - o Payment (see points 2 & 3 for fees and payment methods).
 - o Additional Documentation listed under points 2 (Single Entry Visa).
- 2. The application must be supported by:
 - o Evidence of Accommodation in Thailand.
 - o Evidence of Adequate Finance showing no less than AUD \$800 as follows:
 - Official Bank Statement issued within the last 6 months, linked to the applicant by name and closing balance AND/OR
 - > Official Credit Card Statement, illustrating the current balance and credit card limit.
 - o A fee of **AUD \$55** to be paid in Australian Dollars and made out to 'Royal Thai Consulate General Melbourne' by the following methods: <u>bank cheque, money order or cash</u> only.

 Personal and company cheques WILL NOT be accepted.
 - o For visa applications made in person, visas will take 2 working days to process once a complete application has been received. For applications made via mail, a processing time of 2 business days <u>does not</u> include postage times. For advice on postage times, please contact your local post office.
 - o <u>Visas by Mail:</u> All applications sent via mail must include all of the requirements and payment made out to 'Royal Thai Consulate General Melbourne'.

Important: Visa applications will only be accepted if they are sent via registered post and will only be returned if they include a self-addressed registered envelope, or express post with signature on delivery.
