Tourist Visa

Single Entry/Multiple Entries

- Passport or travel document with a minimum validity of 6 months from the entry date.
- Visa application form, fully completed
- Recent passport-sized photograph (3.5 x 4.5 cm) of the applicant
- For non-Australian or non-resident applicant, proof of an Australian Electronic Visa (VEVO)
- Copy of an airline ticket indicating the date of arrival to and departure from Thailand or letter stating the itinerary/ travel plan of the applicant.
- Copy of updated bank statement providing of adequate finances of AUD 950 per person (THB 20,000) or AUD 2,000 per family (THB 40,000)
- Confirmed accommodation under your name for the duration of your stay in Thailand
- Proof of residential address in Australia
- In case of a medical tourist visa (MT), a letter from the hospital in Thailand, medical history, and medical certificate are required
- * **Additional documents required for Tourist visa for Multiple Entries**
- Copy of updated bank statement providing of adequate finances of AUD 8,000 per person (THB 200,000)

Transit Visa

- An original and a copy of Passport or travel document with a minimum validity of 6 months from the entry date.
- Download and complete Visa Application Form
- Recent passport-sized photograph (3.5 x 4.5 cm) of the applicant
- Proof of an Australian Electronic Visa (VEVO) for non-Australian or non-resident applicants
- Copy of updated bank statement providing of adequate finances (THB 10,000 per person, or THB 20,000 per family)
- Confirmed accommodation under your name for the duration of your stay in Thailand
- Invitation letter (for who will participate in sports activities only)
- A copy of airline ticket indicating the date of arrival to Thailand and departure from Thailand to the third country (and for applicants applying for double entries visa, a copy of an airline ticket showing the second entry to Thailand)

Non-Immigrant Visa

Required documents for ALL TYPES of Non-Immigrant Visa

- Passport or travel document with a minimum validity of 6 months from the entry date.
- Visa application form, fully completed
- Recent passport-sized photograph (3.5 x 4.5 cm) of the applicant
- For non-Australian or non-resident applicant, proof of an Australian Electronic Visa (VEVO)
- Copy of updated bank statement providing of adequate finances (THB 20,000 per person, or THB 40,000 per family)
- Copy of an airline ticket indicating the date of arrival to and departure from Thailand or letter stating the itinerary/ travel plan of the applicant.

Additional Documents Required for EACH TYPE of Non-Immigrant Visa

Non-Immigrant Visa type ED (for education)

- A copy of a school's profile, registration or license in Thailand Transcript/Letter of acceptance from the concerned schools/universities or institutes in Thailand indicating length of stay and your field of study

Non-Immigrant Visa type B (for business and employment)

- Letter from your employer stating your position, length of employment, date and purpose of visit. If you are a business owner, please provide relevant documents
- Invitation letter (or email, etc.) from your host company/organization in Thailand indicating the length of stay and purpose of your visit
- Copy of Thai company registration
- Letter of acceptance from your employer in Thailand (for employment only)
- Copy of your work contract (for employment only) / valid work permit
- For teachers in private schools, a letter of approval from Thai government agencies such as the Office of the Private Education Commission of the Office of the Basic Education Commission
- Copy of working with children check, AFP check, teaching card (only applies to applicants proposing to teach and/or undertake work associated with minors under 20 years old)

Non-Immigrant Visa type O (for dependent, spouse and family visit, or spouse of Thai national)

- A confirmation letter from spouse or family member
- Copy of the visa or work permit of a spouse or parent who is currently working in Thailand
- Proof of your relationship, such as marriage certificate or birth certificate
- Copy of Thai ID Card / passport

Non-Immigrant Visa type O (for volunteer or NGO)

- Invitation or acceptance letter from the host organization in Thailand indicating your position, responsibilities and length of stay in Thailand
- Copy of the host organization's registration or license in Thailand as a non-profit organization
- Copy of the passport or ID card of the person who signed the invitation or acceptance letter
- Copy of working with children check, AFP check, teaching card (only applies to applicants proposing to teach and/or undertake work associated with minors under 20 years old)

For nationals of: Afghanistan, Algeria, Bangladesh, Cameroon, Central African Republic, China, Congo, Egypt, Equatorial Guinea, Ghana, Guinea, India, Iran, Iraq, North Korea, Lebanon, Liberia, Libya, Nepal, Nigeria, Pakistan, Palestine, Sao Tome and Principe, Sierra Leone, Somalia, Sri Lanka, Sudan, Syria, Yemen, Stateless and Unspecified.
