\*Released on April 20, 2020 - please be advised that new information may be released and updates to these considerations may need to be taken into consideration. Please be mindful that these are considerations and not programming requirements.

There are a number of virtual platform options that can be used to conduct remote supervised visitations. Selecting a platform that supports the highest level of security is essential.

Inspire Action for Social Change recommends SV&SE programs use a virtual platform when conducting both phone or virtual supervised visitation services. The virtual platform should have setting and security features that offer the following options:

- Encrypted and secure connection with a required password login.
- Video-or phone-only connection options within the same call that allow the program to decide what is the safest method for each participant to join the remote visit.
- Joining controls that allow the host to join individuals to the call when ready (such as a "waiting room" or "on hold" option before being allowed to join).
- Host-only controls that support an instant mute function for both audio and video connections.
- Host-only controls to move participants out of the session quickly.
- Host-only controls to move participants into another "room" or "breakout session" quickly so the visitation monitor can talk privately with anyone on the call.
- Host-only monitoring of everyone who is on the call.
- Host-only ability to mask the call-in number of participants.
- Host-only ability to monitor or turn off any chat features.
- Host-only screen sharing mode and blocking ability.

**Please note:** there are several virtual platform options available. It is your responsibility to ensure your selection meets your programming needs, complies with your program policies, and meets local,

state, and federal laws and mandates.

Zoom is one virtual hosting platform option. If you have chosen Zoom to use as your remote SV&SE platform, we have provided the following helpful tips and links to ensure you have set up your Zoom account settings to create a safe and secure platform with the capability to conduct remote supervised visitation services.

If you have decided to use Zoom as your remote supervised visitation virtual platform, Inspire Action strongly suggests SV&SE providers utilize either the "Pro" or "Business" Zoom account due to the extra functions, safety features, and protected and encrypted connection options provided. #### When you set up your Zoom account:


- Ensure the platform offers a secure, password-protected, and encrypted connection.
- Ensure your account is an upgraded account (Pro or Business) that provides an encrypted and secure connection.
- Ensure that you click on the "Require Meeting Password" box.

## To ensure you have all of the remote SV platform safety and security functions set up correctly, please check the following:

- Each visitation monitor should have an enabled and functioning video camera and microphone on their computer.
  - Conduct a Meeting Audio Test
  - Conduct a Meeting Video Test
- Video- or phone-only connection options should be available within the same call.
  - How to Schedule a Video or Phone Call
- Enable join from your browser, this will allow the participant to join without downloading the Zoom app.
  - Join From Your Browser Link
- Host alone should have the ability to mask the call-in number of participants before joining the session.
  - In your Zoom settings, click on the Telephone section to enable "mask phone number."(Please refer to the screenshot below for further details on how to enable this setting.)



# Guide to Using Zoom as the Virtual Video or Audio Platform to Conduct Remote Supervised Visitation\*



- Host alone should have the ability to monitor or turn off any chat features.
  - Controlling & Disabling Chat Features
- Host alone should be able to move participants out of the session quickly, start and stop the video, rename a participant, turn on an "enter and exit" chime, and other managing features. Here is a 10minute tutorial link on how to do this:

- Host should have joining controls enabled that allow the host to join individuals to the call when ready (such as a "waiting room" or "on hold" option before being allowed to join).

- Host alone should be able to move participants into another "room" or "breakout session" quickly so the visitation monitor can talk privately with anyone on the call.

### Final Setup Checklist for Successfully Using Zoom for Remote Visitation

- Ensure all staff are fully trained on the Zoom platform and have held practice sessions to make sure staff are familiar with all the settings, practice if problems arise, and how interventions will be made.
- Ensure staff connects early to allow time for any tech troubleshooting.
- Make sure the camera and microphone operate correctly.
- Disable chat for everyone except staff, or enable chat (and after starting the meeting, make sure participants can only chat with the host).



# Guide to Using Zoom as the Virtual Video or Audio Platform to Conduct Remote Supervised Visitation\*

- Make sure your enable waiting rooms settings have been enabled.
- Set up breakout rooms.
- Disable screen sharing and whiteboard for everyone except staff.
- Check settings to make sure participants cannot unmute themselves.
- Check settings to ensure participants cannot rename themselves.
- Enable co-host (if applicable) and/or define alternate host (if applicable).
- Hide the participants' profile pictures.
- Turn off live-streaming.
- Enable the "Join from your browser" feature so the Zoom app is not needed.
- Invite parents with the correct meeting link and password.
- Make sure Zoom links for visits are sent to each parent separately so they won't have the other's email address.
- Make sure Zoom links are sent to staff separately so parents won't have staff email addresses (if the staff is using a different email than work email).
- Lock room after everyone has joined.
