You will need to get started with a Rule 25 assessment through your county or tribal office. Call your local Health and Human Services Department to schedule this assessment. A: Call the number on the back of your insurance card to see if we are in your network.

A Rule 25 assessment will still need to be completed to be approved prior to admitting.
