

2017 RELEASE AND HOLD HARMLESS AGREEMENT

In exchange for the opportunity to gain volunteer experience and/or to participate in the production of "Nightmare at Beaver Lake" an indoor/outdoor haunt production produced by ROTARY CLUB OF SAMMAMISH and SCARE PRODUCTIONS, INC, the undersigned(s) individually and as parents(s) and/or legal guardians of _____ ("PARTICIPANT") agree to release and hold harmless the Rotary Club of Sammamish, Sammamish Rotary Foundation, Rotary District 5030, Rotary International, Rotary International Foundation, Scare Productions, Inc., The City of Sammamish, City of Sammamish Parks and Recreation and all their respective employees, directors, board members, officers, members, officials and any and all other persons, firms, volunteer coordinators, corporations or entities having any interest in or connection with said organization(s), and each and all of them, of and from any and all claims of whatever nature from any liability that may arise in connection with the Nightmare at Beaver Lake production and/or with the above named volunteer's participation in any capacity in the production.

"Nightmare at Beaver Lake" consists of a large indoor/outdoor Halloween haunted house including make shift indoor structures and several acres outdoors. The persons signing this agreement acknowledge that the "Nightmare at Beaver Lake" includes but is not limited to work in wooded areas often during hours of darkness on uneven and wet terrain, working with large handmade props, crowds of people and work while wearing costumes. Conditions may be crude and not optimally safe. THERE IS RISK OF POTENTIAL HARM THAT MAY RESULT IN PERMANT INJURY, DISABILITY OR DEATH. The persons signing this release acknowledge and accept these risks on behalf of themselves and/or on behalf of the above named minor PARTICIPANT.

The undersigned acknowledges that he/she/they are responsible for obtaining and maintaining health insurance on the PARTICIPANT during the time of the above named PARTICIPANT'S involvement in any capacity in the project and certify that such insurance will be in place during the entire time the above named PARTICIPANT is involved in any aspect of the production. On behalf of the insurer, the signers waive any right of subrogation against the releasees of their insurers that may be asserted by the PARTICIPANT'S health and accident insurer.

This is further a release from all claims whatsoever from any liability that may arise in connection with the taking of pictures and filming of PARTICIPANTS during and after all phases of the production. These pictures will be used for promotional purposes. Without limiting the general application of the foregoing, the undersigned specifically consents to be the subject of photographic works and images, and releases and assigns to **Rotary Club of Sammamish** all of his or her rights, including copyrights, personality rights or any other legal rights in and to any photographic works and images, audio reproductions, or derivations therefrom, created by anyone who is a member of any of the above named organizations.
